No damages observed on the bus. The electrical box did not appear damaged other than being lifted from its concrete base. Students were exchanged to a new bus to be transported home.

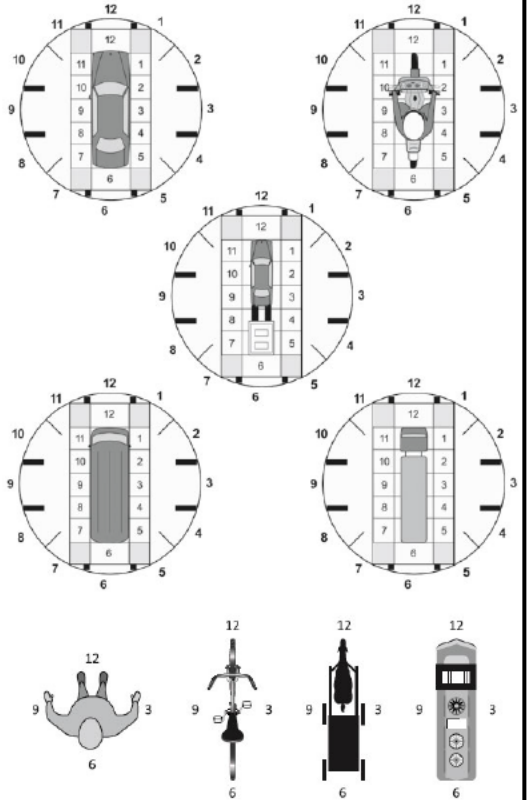

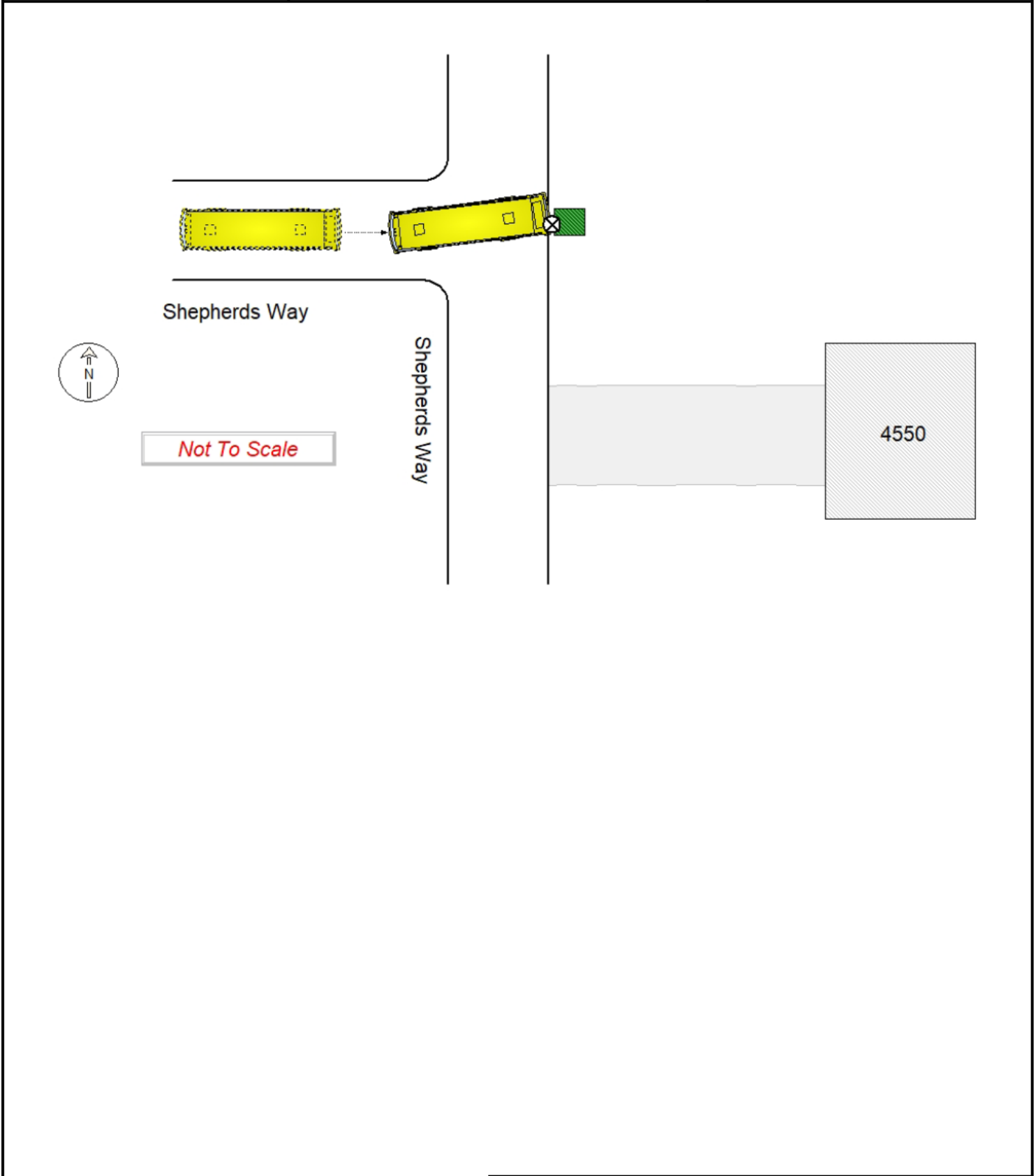
