Troy said he was traveling South bound on Clermontville Laurel Rd. when his driver side vehicle mirror was struck by another vehicle traveling North bound on the same road. He said he turned around and followed the vehicle a white color Dodge truck OH-ERY7194 to a residence on the same road. He told me he spoke to the driver Mr. Joel Haas and they agreed Joel was at fault. He told me he returned to the area of the accident to wait for Police. I responded to the residence of Joel with Troy and spoke to Joel and at first he said he struck the mirror of Troy. After more conversation Joel said he did not agree that he was at fault. 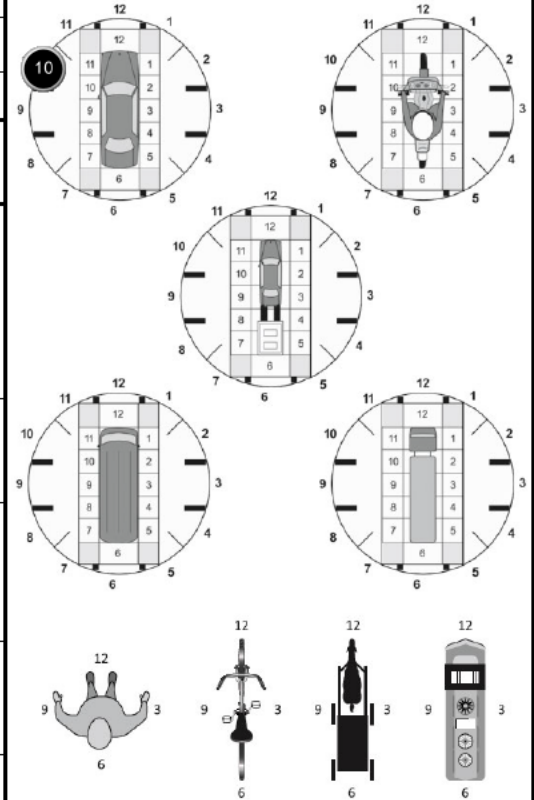

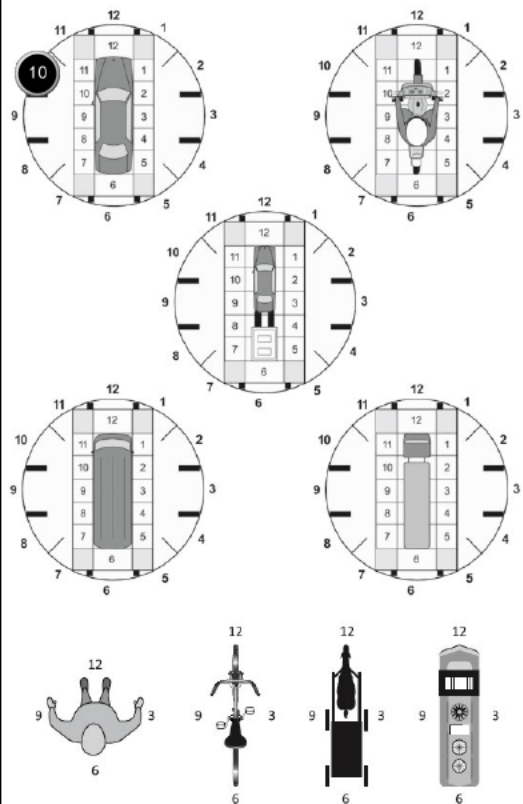
