NARRATIVE On January 4, 2025 at 1744 hours, I was dispatched to the area of Old SR 32 / Hill Top Ln in Batavia Township for a single vehicle MVA into a guard rail. The vehicle involved is a gray 2013 Infinity JX35 (SUV) bearing Ohio Registration JSK7062. Upon my arrival at 1751 hours, I made contact with the sole occupant, Ms. Alexis Gosser outside of the vehicle. Alexis advised she was not injured during the accident. I observed heavy damage to the front driver side of the vehicle with fluid leaking. Alexis advised she was traveling WB on SR 32 when she slid on a sheet of ice in the roadway causing her vehicle to go left of center, striking the guard rail on the EB shoulder. During this investigation I did not locate any sheet of ice in the roadway. It was determined the Alexis was traveling WB when she went off the roadway. Alexis over corrected causing her to travel left of center striking the guard rail on the EB shoulder. The vehicle was towed by Grays Towing Company.

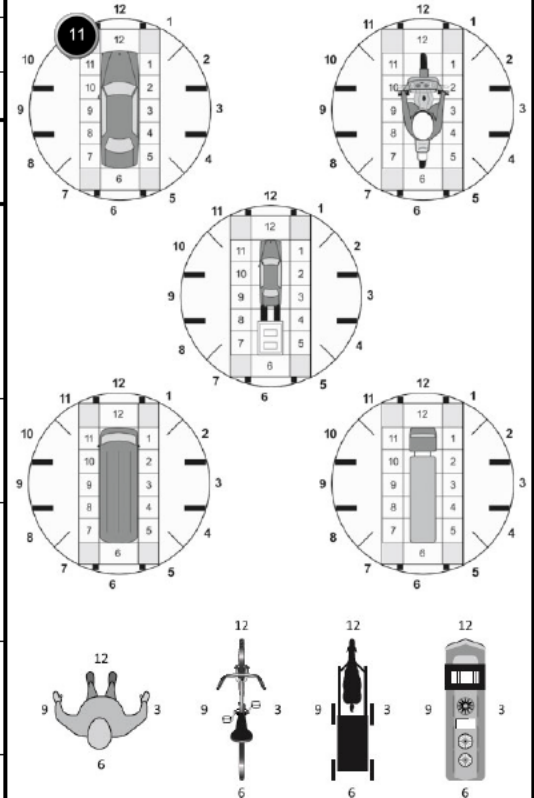

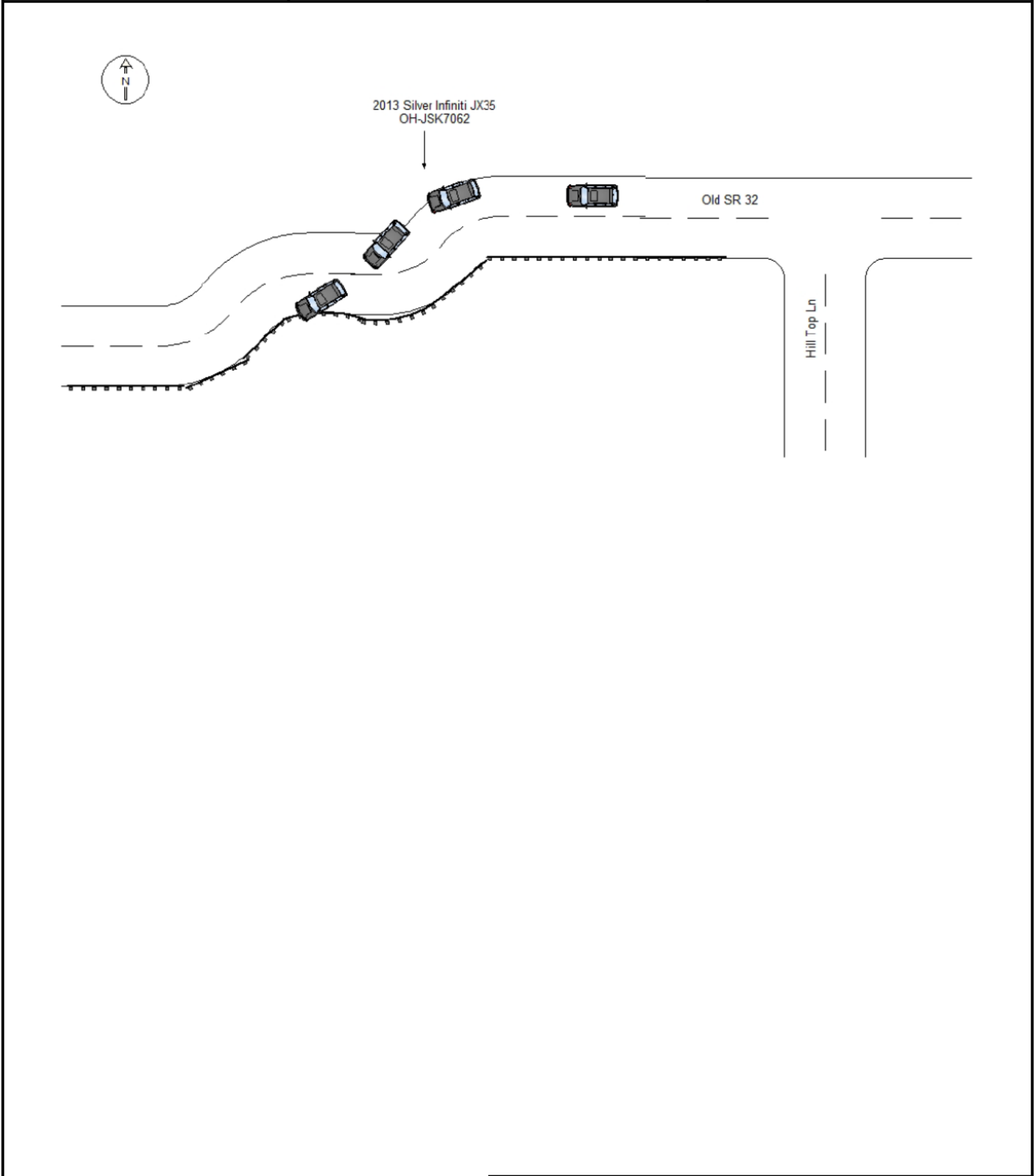
