NARRATIVE On 01/05/2025 at 1358 hrs. I responded to the intersection of Chapel Rd. and Mt. Holly Rd. in Clermont County OH. Batavia Twp. Unit 1 (OH HNG-8515) driven by Mr. Rodney Messer who was traveling northbound on Mt. Holly Rd. failed to stop at the stop sign in the intersection listed above. The conditions were snow covered roads with snow activity present and the roads were considered very slick. Mr. Messer slid through the intersection and struck Unit 2 (OH ERY-9171) driven by Mr. Andrew Erickson) in the right side of his 2006 Honda Accord causing him to hit the guard rail with the rear of his vehicle, then continue to spin counter clockwise striking the guard rail again in the front of his car. Mr. Erickson's side and front airbags were deployed. Mr. Erickson complained of back pain but refused transport to the hospital for an evaluation.

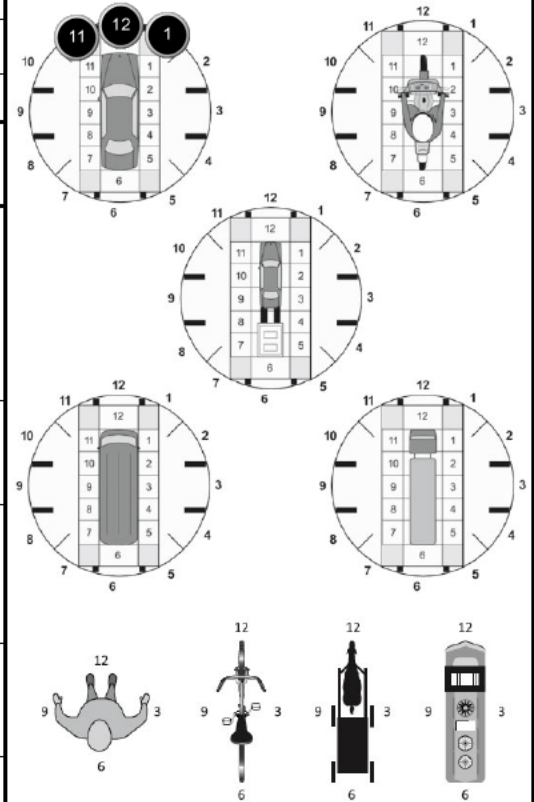

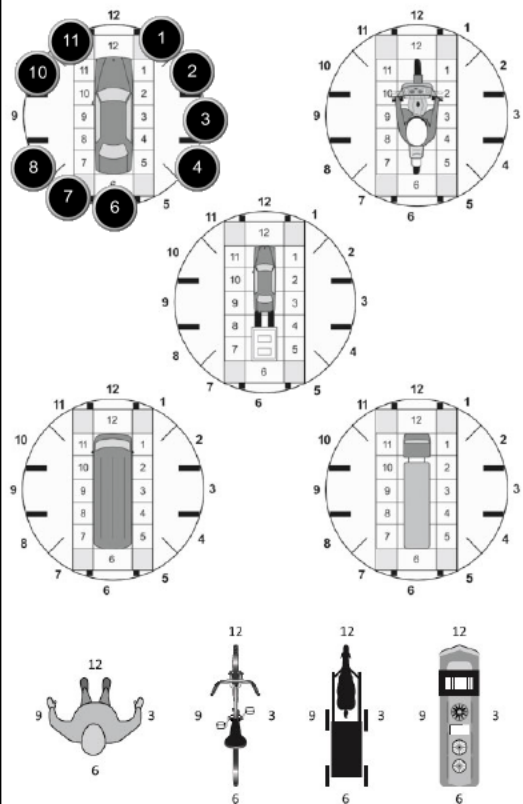

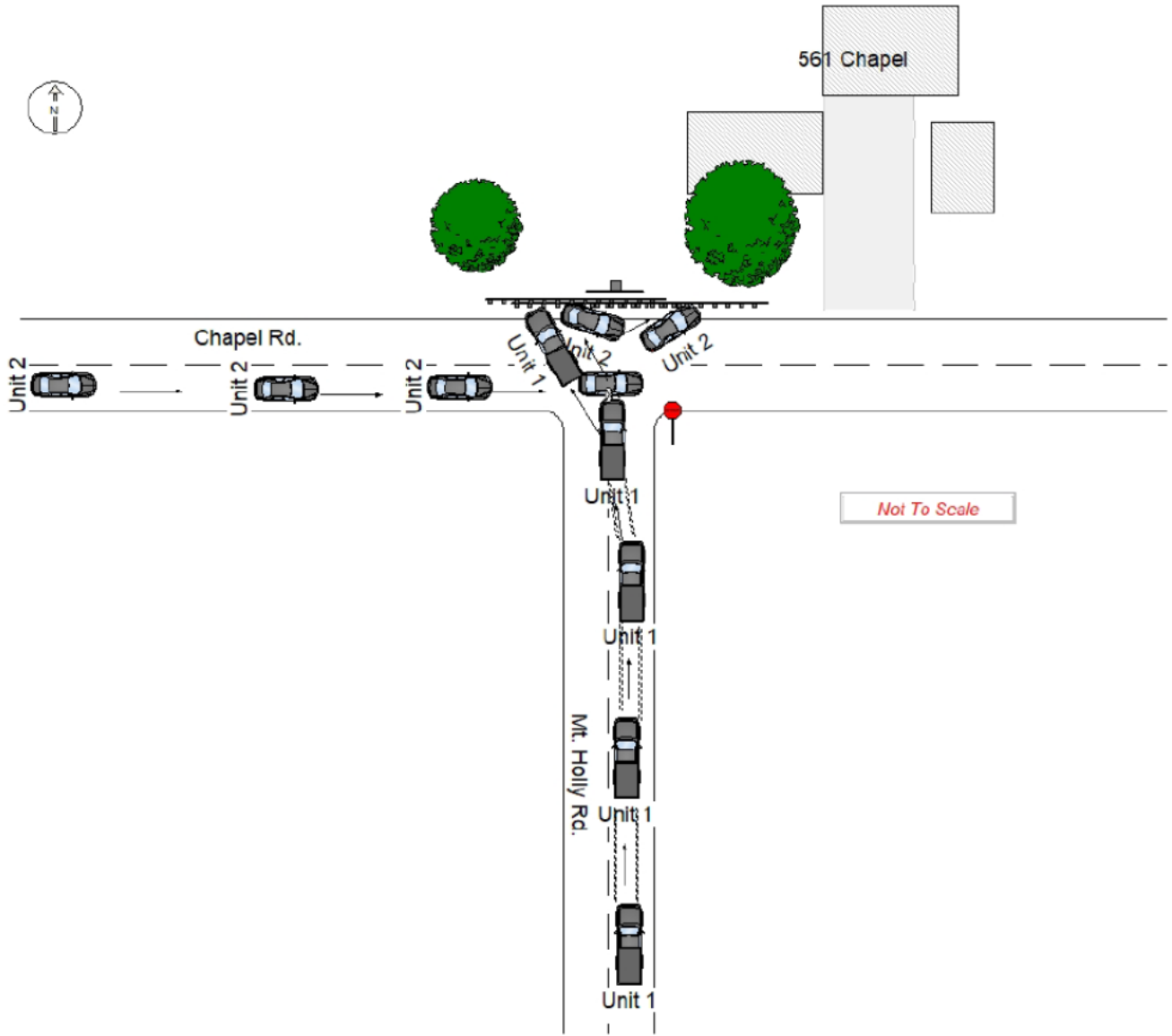
