Upon my arrival at 1739 hours, I observed both vehicles to be occupied by a sole occupant. The vehicles involved is a red 2024 Acura RDX OH-KJW4814 (Unit #1) and a 2017 silver Ford Explorer OH-HMB1789. Unit #1 driver was identified as Ms. Barbara Phillips and Unit #2 driver was identified as Ms. Emily Akers. During the investigation it was determined that Unit #2 approached the 3 way intersection first and proceeded SB on Olive Branch Stonelick Rd. Unit #1 approached the intersection, failed to yield and proceeded to turn SB onto Olive Branch Stonelick Rd when she struck Unit #2 causing damage to the front passenger side wheel well. No injuries were reported from both occupants. Photographs were obtained at the scene, Subjects were then sent on their way.

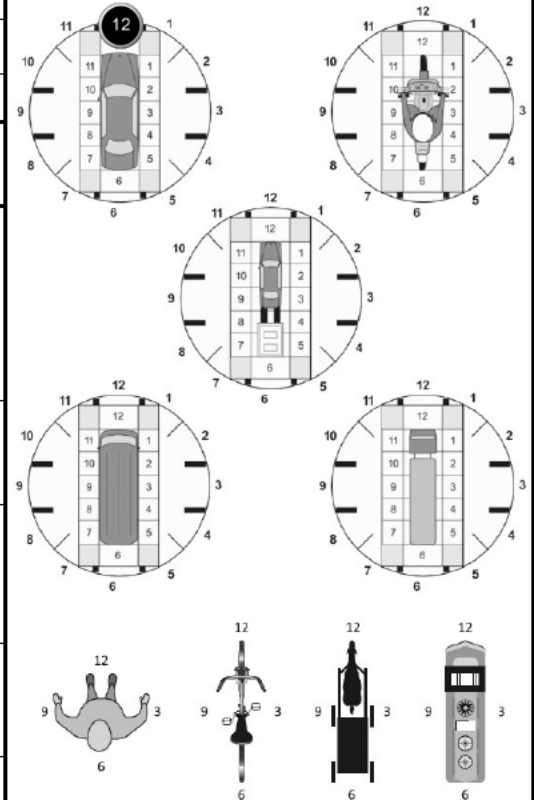

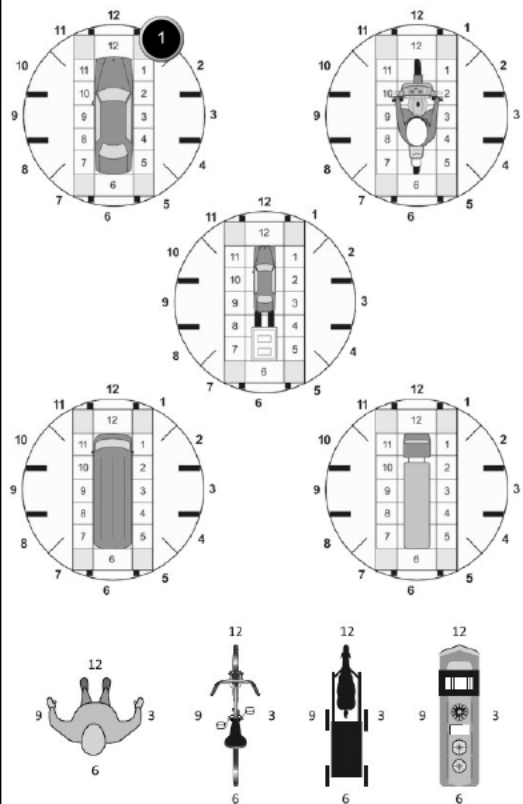

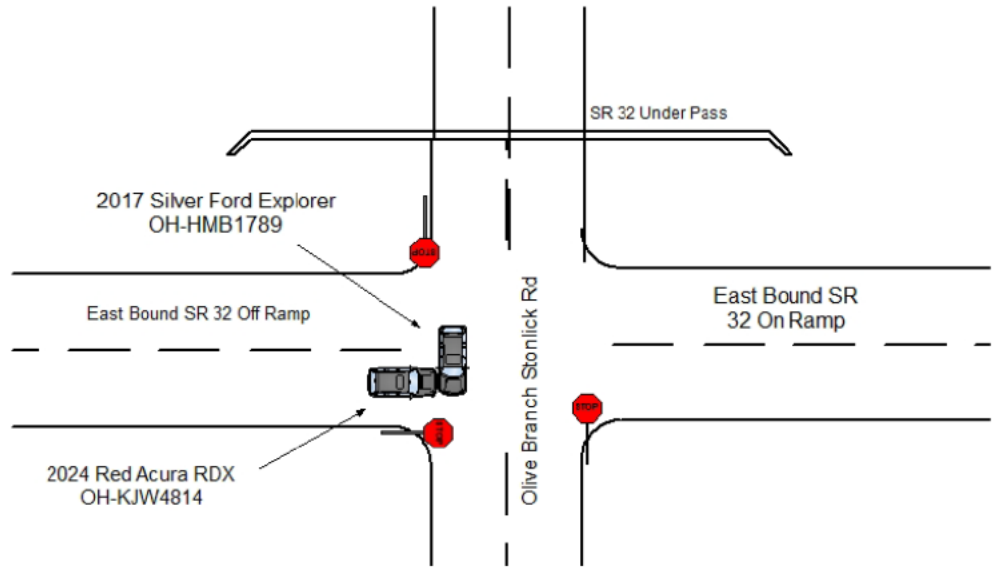
