NARRATIVE On 2-11-2025 at 1730 hours 2 vehicles pulled into Phantom Fireworks at 2076 SR 125 in Batavia Township to report a motor vehicle accident. I spoke with the driver of a 2023 Toyota 4 Runner, Mrs. Amy Sumner and she stated she was driving south on SR 222 and came to a stop at near the traffic light at the intersection of SR 125. She states she was then struck from behind. I then spoke with the driver of a 2002 Kia Spectra, Mr. Richard Hamm. He stated he was traveling south on SR 222 towards 125 and when he came over the hill and applied the brakes to stop his car began to slide due to the snow and icy road conditions. Mr. Hamm stated he attempted to go to the left of the vehicle in front of him to avoid hitting it but was unsuccessful. He then struck the rear of Mrs. Sumner's vehicle. Both parties stated they were wearing their seat belt and there were no injuries reported. There was minor/functional damage to the rear of Mrs. Sumner's vehicle and significant, but drivable damage to the front of Mr. Hamm's vehicle.

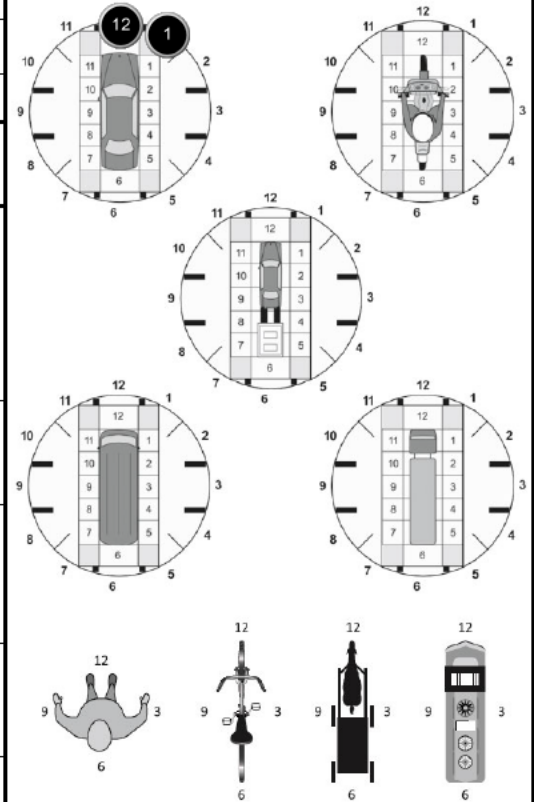
