NARRATIVE On 02-12-2025, At 2339 hours, I responded to 3689 White Blossom Court in Batavia Township, Clermont County, Ohio for a report of an Accident. Upon arrival, I made contact with the driver of the vehicle, A.J. (16YOF). A.J. advised she was in her car with two friends and they were coming back from Taco Bell. A.J. explained she was coming down AOB and hit a puddle, causing her to Hydro plane. A.J. advised she lost control and struck a mailbox on AOB but was unsure where. I located the struck mailbox at 132 AOB. The mailbox was in several pieces and I could see tire tracks leading from the roadway, up onto the sidewalk and over where the mailbox had been in the ground. I located several pieces of debris which matched A.J.'s vehicle. A.J.'s vehicle had several dents to it which she advised were from striking the mailbox. A.J. also had a blown out tire from striking the mailbox. A.J. did have damage from a previous accident as well. A.J. and the other juveniles contacted their parents and I advised them of what had happened.

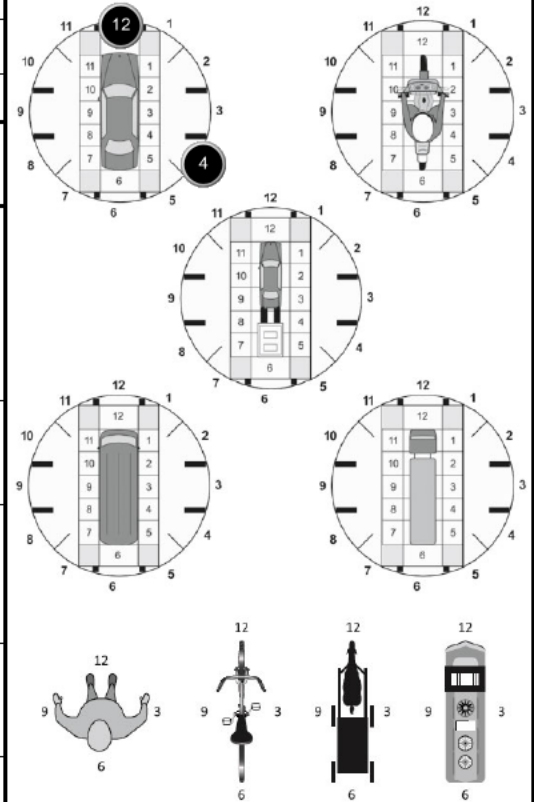
