While trying to pass unit 2 unit 1 struck the front driver side fender of unit 2. Unit 1 then fled the scene without stopping after the accident.

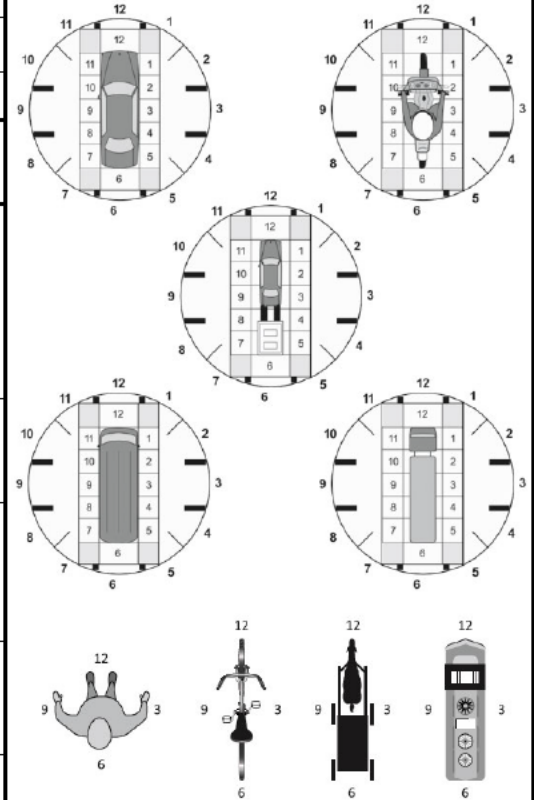

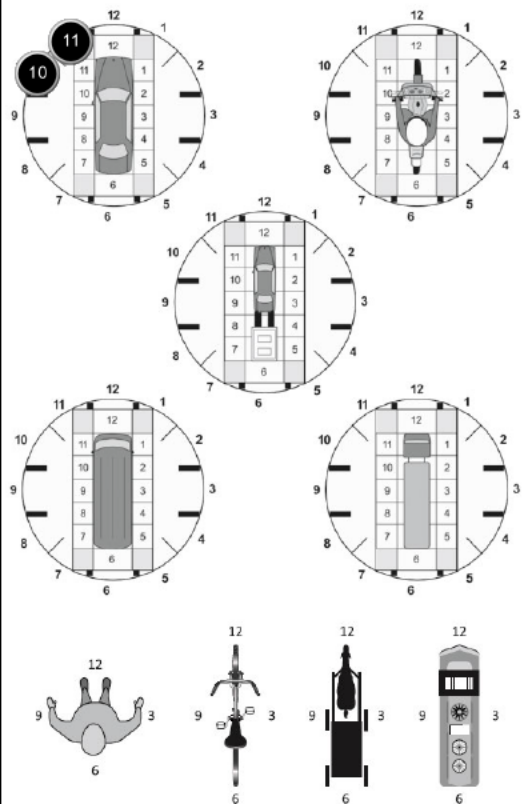
