I arrived on scene at 1848 hours and observed a white box truck that had scraped the driver side of a Jeep Grand Cherokee in the driveway. I made contact with the driver of the white box truck, Davon Kindell. Davon advised that he works for Global Medical Products and was picking up some equipment at this residence. Devon stated he accidentally scraped the side of the Jeep while pulling out of the driveway. I observed an scrape mark on the rear driver side of the Jeep and on the rear driver side of the box truck. I spoke with the owner of the Jeep, Christy Stropes who stated that this is her parents residence and she was just here visiting. I collected Christy's insurance information and then attempted to get Davon's but he advised that he did not have any of the company's insurance information on him. 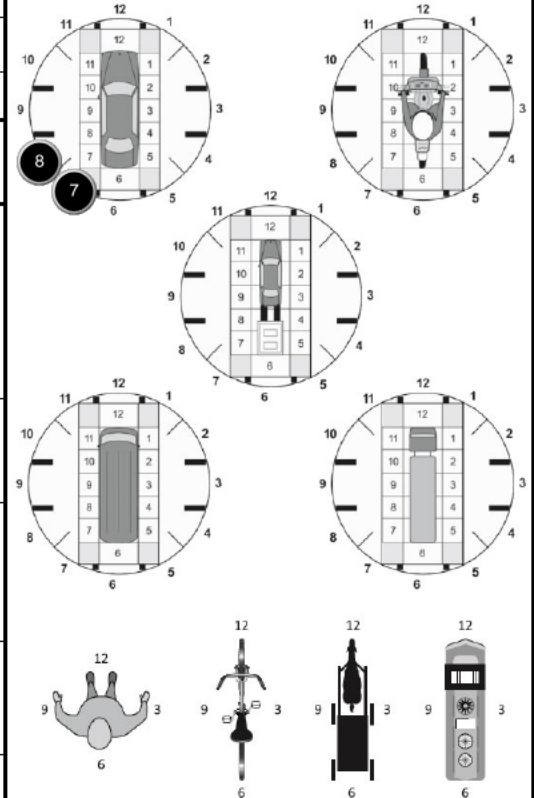

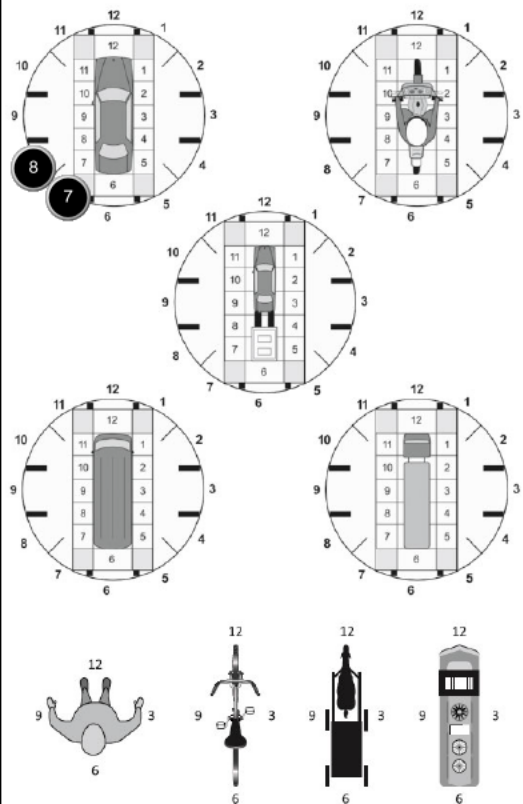
