

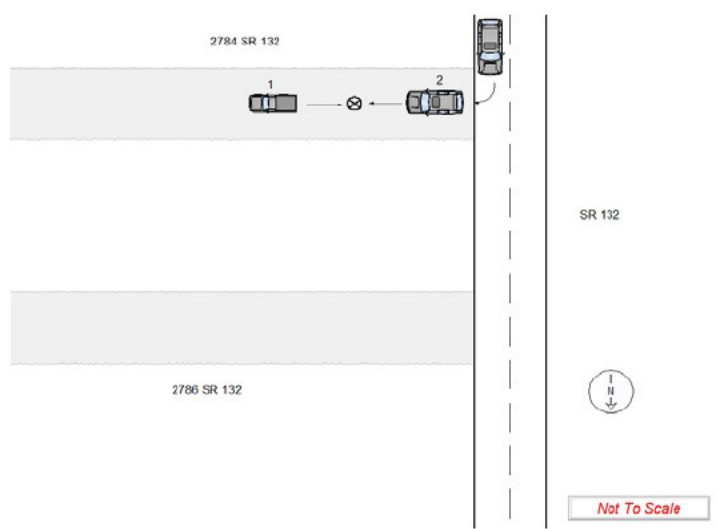

Upon arrival I spoke with the delivery driver that appeared to be using his personal vehicle to make deliveries for Amazon. The driver Christopher Bosshardt stated he was pulling into this driveway because he believed it was 2786 SR 132. As he entered the driveway, the homeowner David Bray was backing his vehicle out of the driveway. The two vehicle collided in the driveway. Mr. Bosshardt claims he was stopped in the driveway and Mr. Bray continued to back up striking his vehicle. Mr. Bray advised as he was backing up Mr. Bosshardt pulled into the driveway at the same time causing the two vehicle to strike each other. There was minor damage to Mr. Bosshardt's vehicle on the front passenger side. Mr. Bray advised he had insurance through progressive but has allowed his insurance to lapse. I could not issue Mr. Bray a citation for not having insurance since the crash occurred on his property. I took photographs of the damage to Mr. Bosshardt's vehicle. Mr. Bray's vehicle did not appear to have any damage.</p>

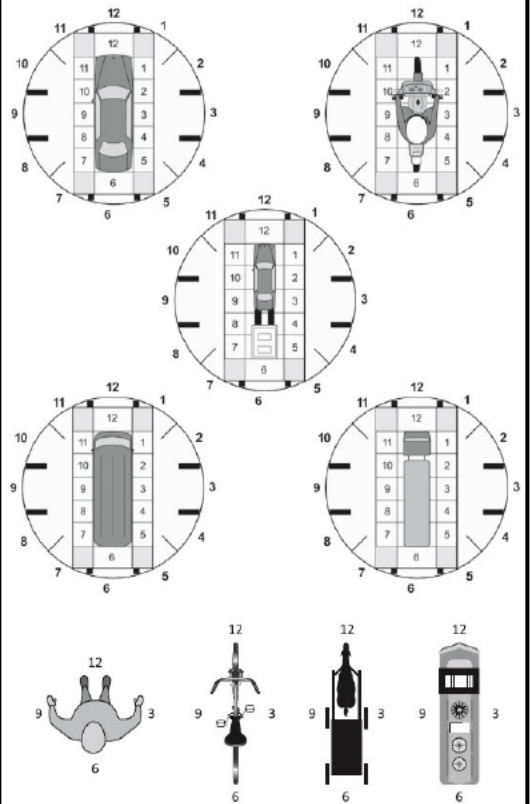

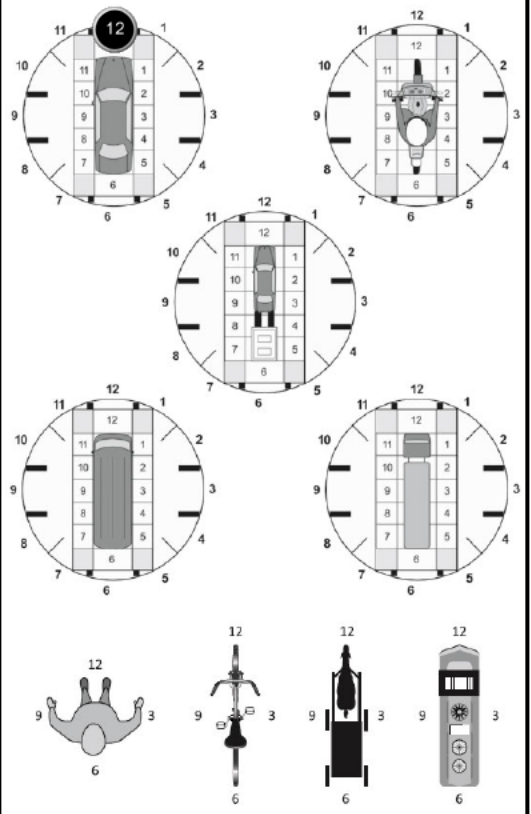
