NARRATIVE On 05/28/2025 at 1751 hours, Ohio State Patrol was originally responding to this crash when they had to divert for another incident. I was dispatched to the crash at 1807 hours. Upon arrival, Unit #1 was behind Unit #2 at the traffic light located at SR 125 and Lindale Mt. Holly Road in Batavia Township. The vehicles were in the westbound lanes of traffic. Unit #2 was stopped for a red light when Unit #1 rear ended Unit #2. Unit #1 driver admitted there was a red light and he was having issues with his brakes coming to a stop in time. There was minor damage with a small dent on the back of Unit #2. Unit #1 already had pre-existing damage to the front driver side headlight assembly area. Unit #1 driver was cited for ACDA. No injuries were reported and no airbags were deployed. Subjects exchanged information and left from the scene.

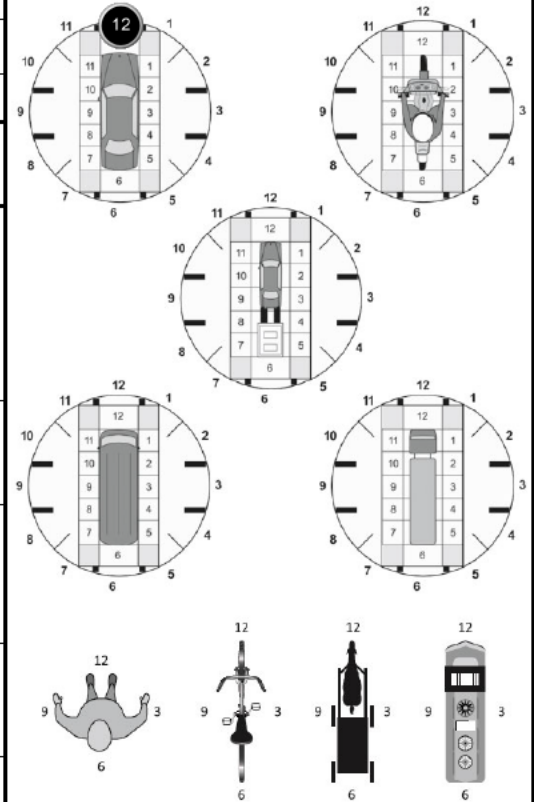

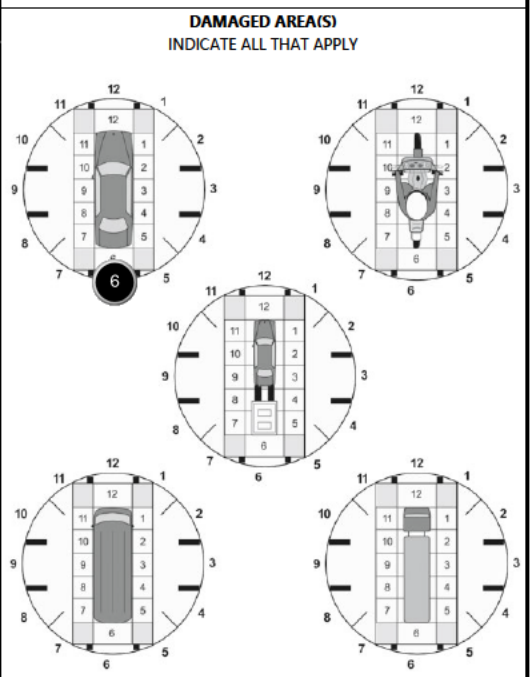

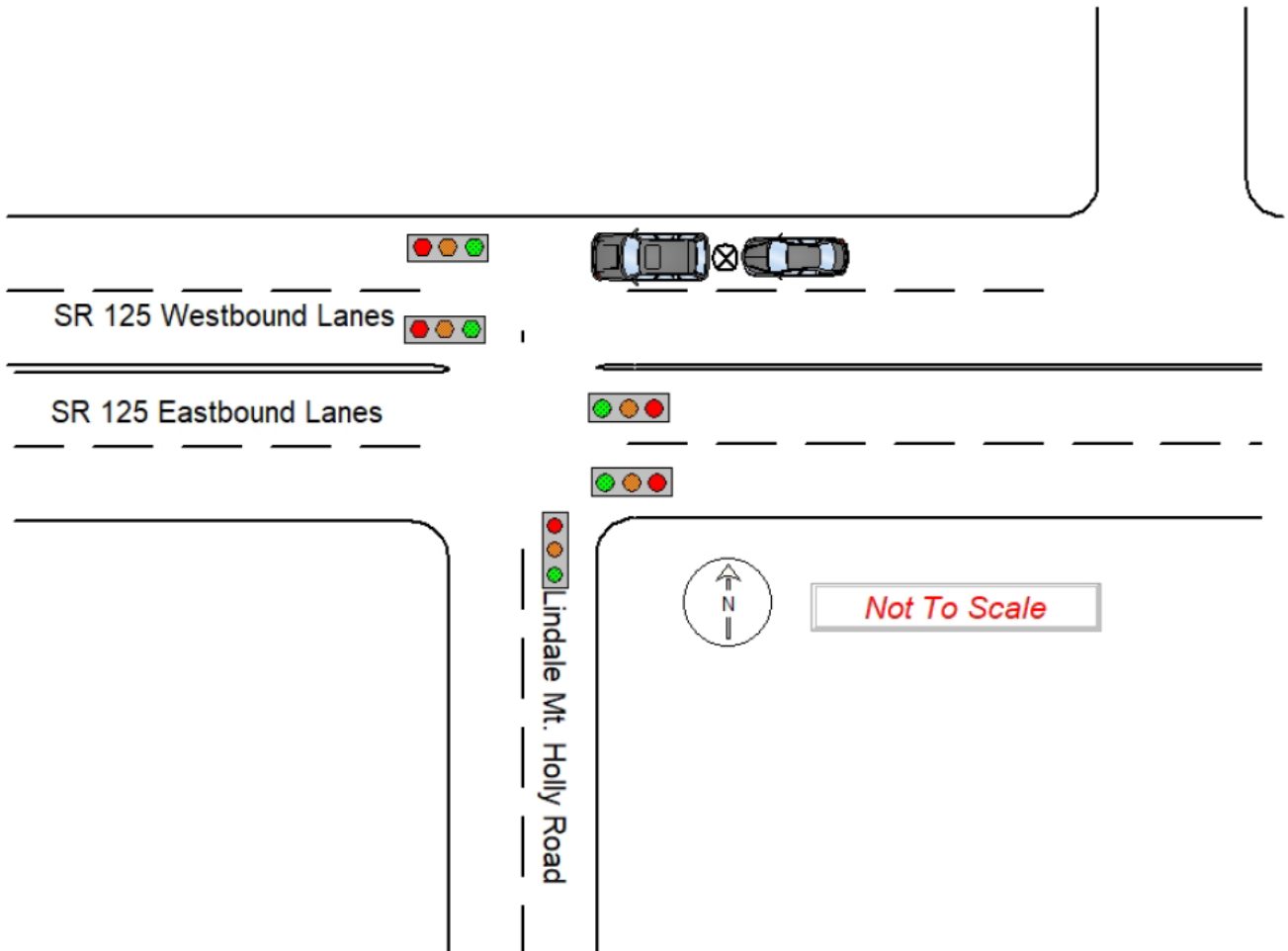
