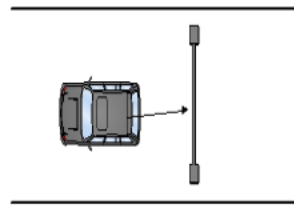

John Foster manager of Whitewater Car wash advised at 1146 on today's date a Gray Dodge OH HOX4193 backed into an electronic gate causing damage to it. Mr. Foster advised the gate later fell on another customer's car. I observed the video footage Mr. Foster provided. At 1143 am a gray dodge enters the car wash. At roughly 1146 hours the vehicle pulls through the exit gate. The gate goes down and the driver of the Dodge accidentally backs into the gate. I made contact with the registered owner Sharlene Webb. Ms. Webb admitted to being at the car wash and stated she did not know she backed into the gate.

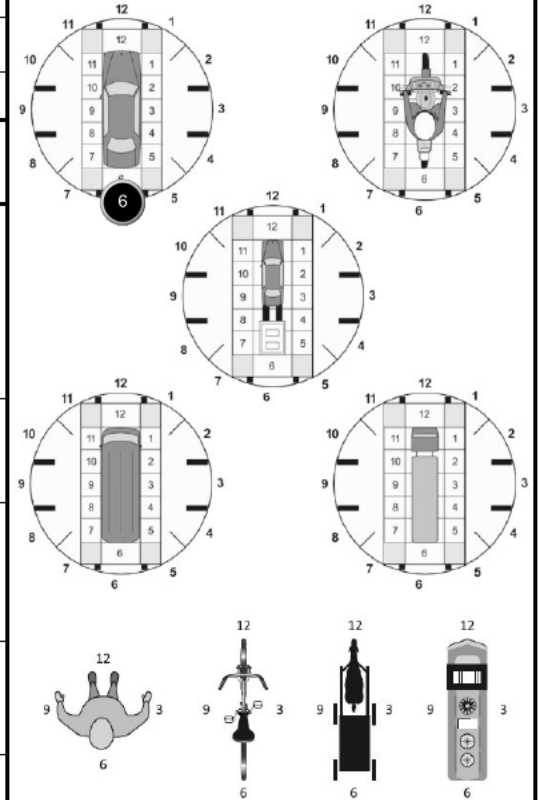
