NARRATIVE Homeowners at 1938 Franklin Laurel Road heard a loud bang outside. Upon investigating, they discovered their mailbox by the road had been run over by a vehicle. A tire mark in the grass could be seen leaving the roadway, going over the area of the mailbox, continuing further in the grass then correcting back onto the roadway. Due to the debris pattern originally found by the homeowner, the vehicle was traveling westbound and left the roadway on the south side of the roadway. Black painted plastic pieces from the bumper were left behind but nothing had any part or serial numbers on the plastic in the debris. There were no cameras on the complainants residence and none observed on neighboring residences. A patrol was conducted in the area with no vehicles found having any damage. Homeowner is Debbie Oberklaus which is listed in the witness section for hearing the crash, but did not observe it.

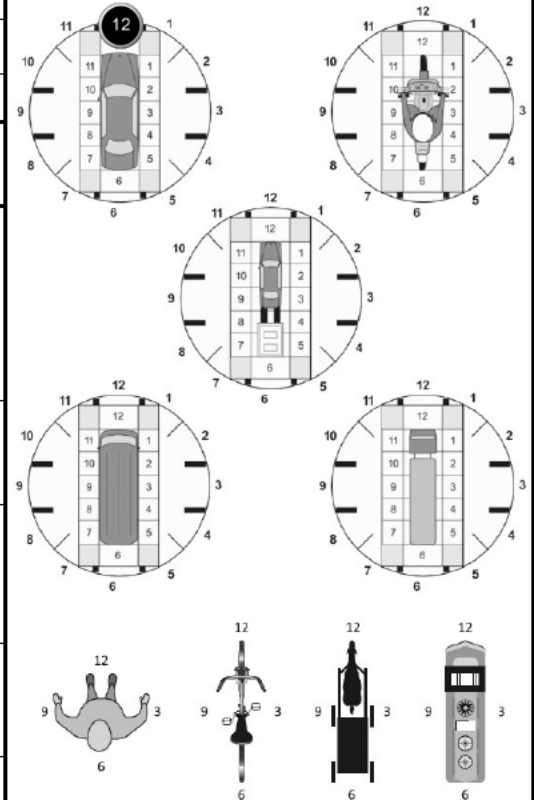

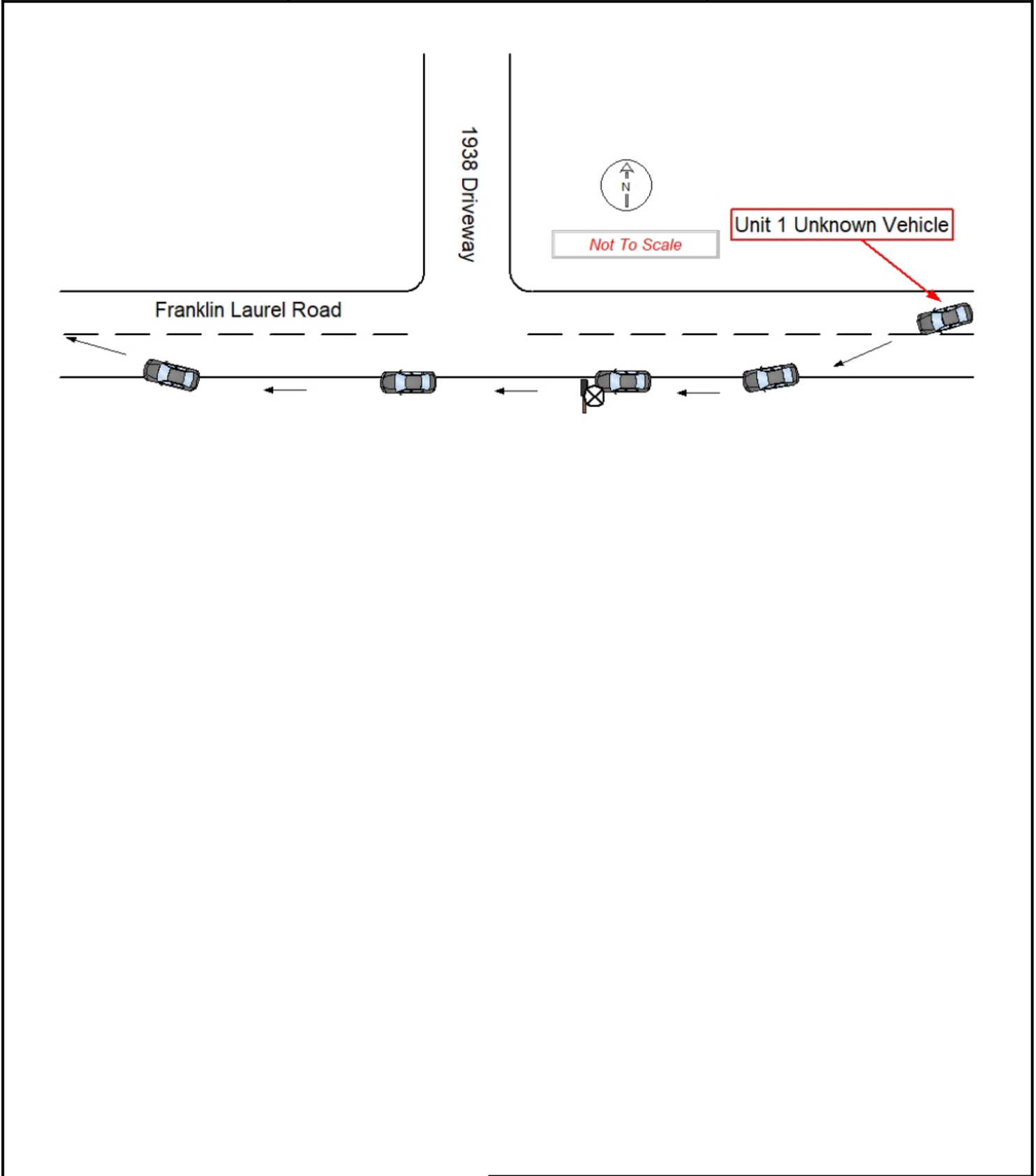
