NARRATIVE On 07-12-2025 at approximately 1906 hours, I was notified of a crash in front of 2848 US 50 in Jackson Twp. Upon my arrival, I noticed a red sedan with damage to the entire rear of the vehicle and a white truck with minor damage to the front bumper and grill. I spoke with the owner of the truck, Mr. Christian Yoak who advised he was driving eastbound on US 50 when a red sedan driven by Mr. Robert Wilson stopped to pull into 2848 US 50. Christian advised that he attempted to hit his breaks but was unable to stop before striking the sedan. 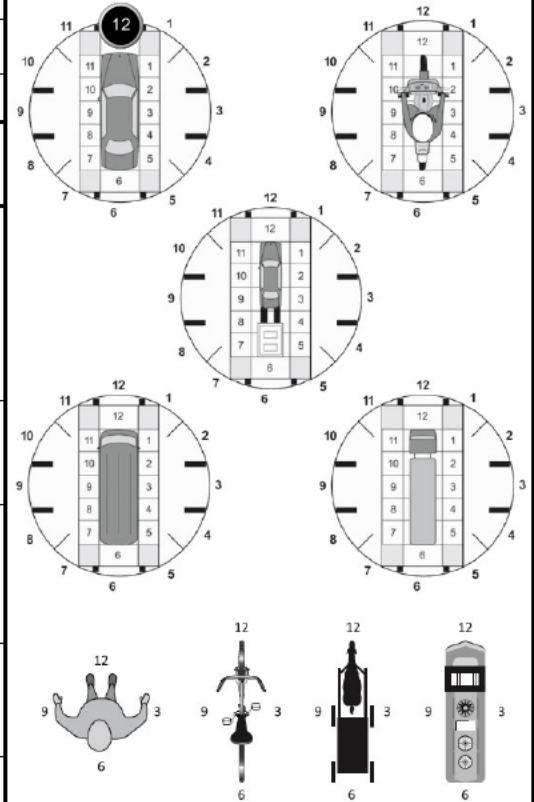

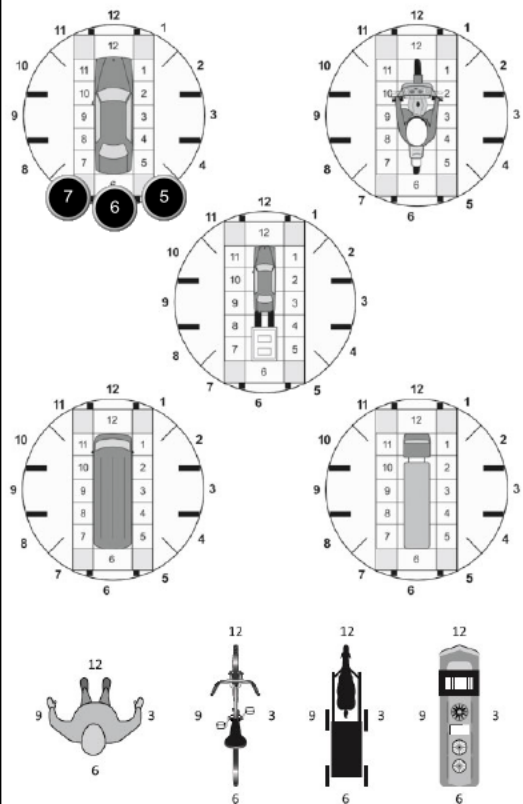
