Mr. Whitt did not hear or see the other vehicle. The vehicle that was struck is registered to TruCraft Roofing Inc. The passenger door appears to have been side swiped. There was no paint transfer and no indication of the striking vehicle.

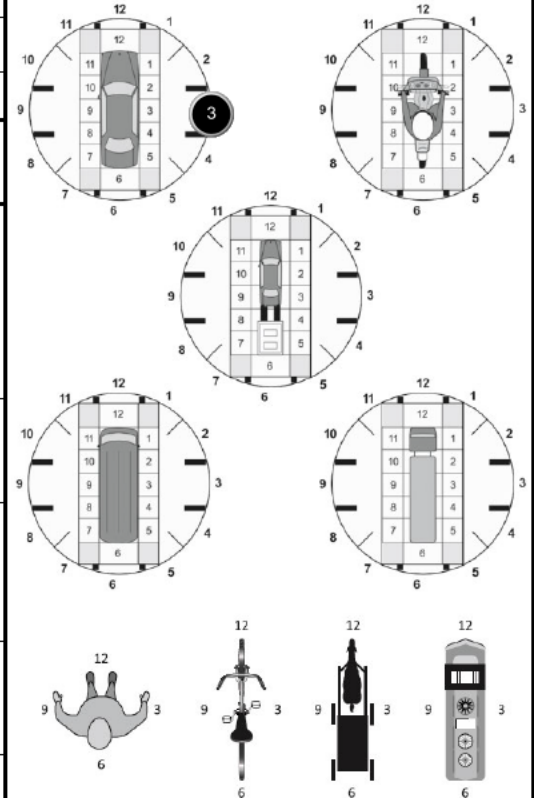

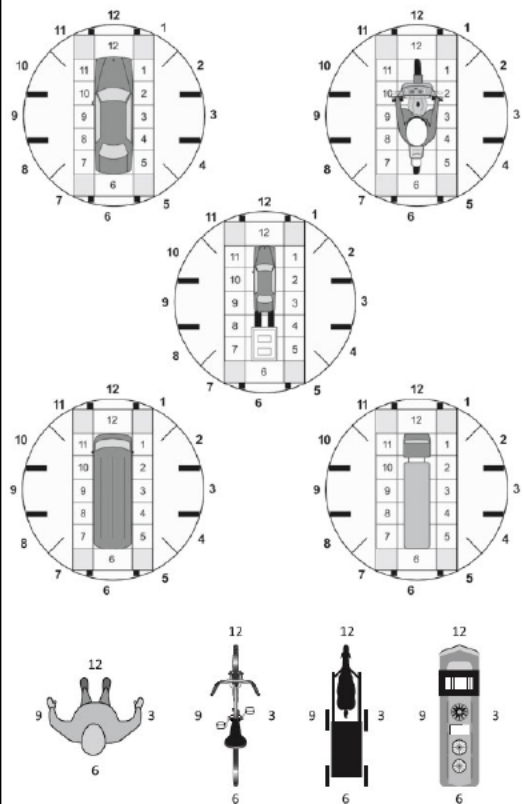
