NARRATIVE Unit 1 was traveling southbound on Sunny Meadow approaching the stop sign at Bay Meadow. Unit 2 was backing out of a driveway after the stop sign. The driver of unit 1 states they stopped at the stop sign and then as they began going unit 2 backed out in front of them. The driver of unit 2 states that unit 1 never stopped, that they ran the stop sign causing the accident. An independant witness, Sebastian McAuliffe 11 year old male, said he witnessed the accident and he said unit 1 never stopped at the stop sign and it ran into unit 2 backing out of the driveway.

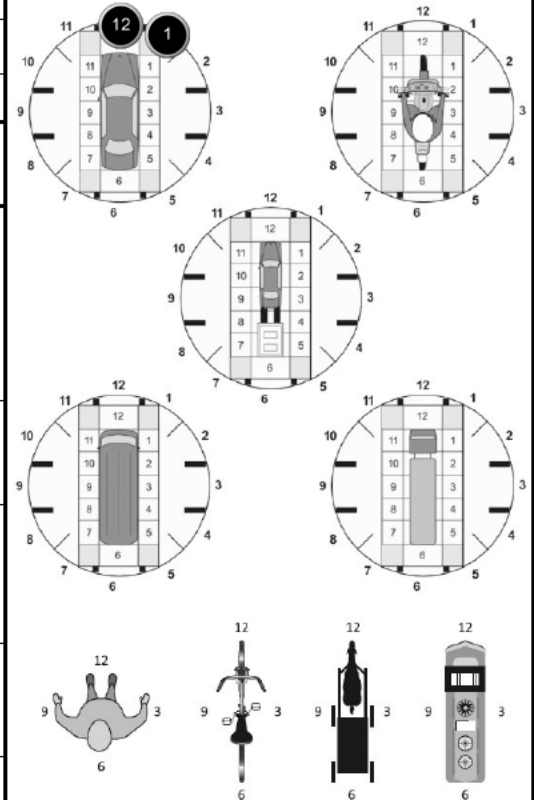
