Upon my arrival at 0852 hours, I made contact with the subjects involved. I observed a blue 2007 blue Dodge Magnum (OH-JDJ5696) with damage to the front passenger side bumper and a 2018 black Honda CR-V (OH-JTL3532) with damage to the driver side rear bumper. The driver of the Dodge was identified as Ms. Amanda Oetzel, who refused EMS and declined any injuries. The Add-On owner for the Honda was identified as Ms. Kayla Williams. Amanda advised she was parked next to Kayla's vehicle in the lot. Upon pulling out of the parking space, Amanda side swiped Kayla's vehicle. 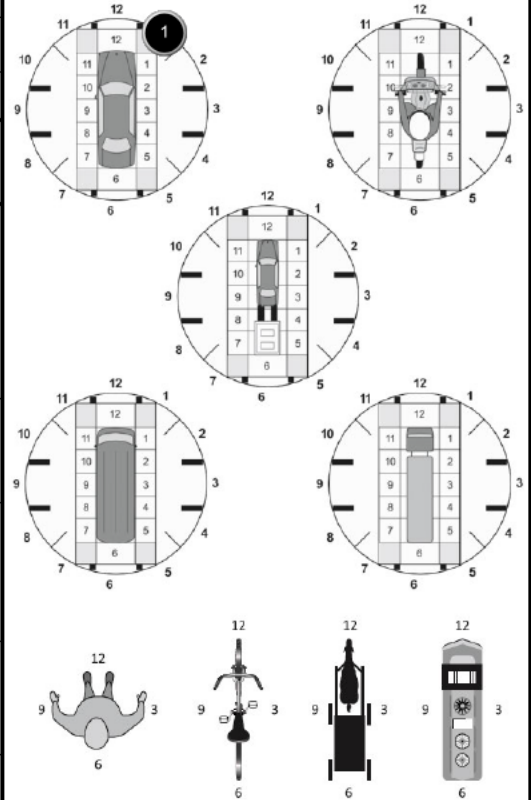

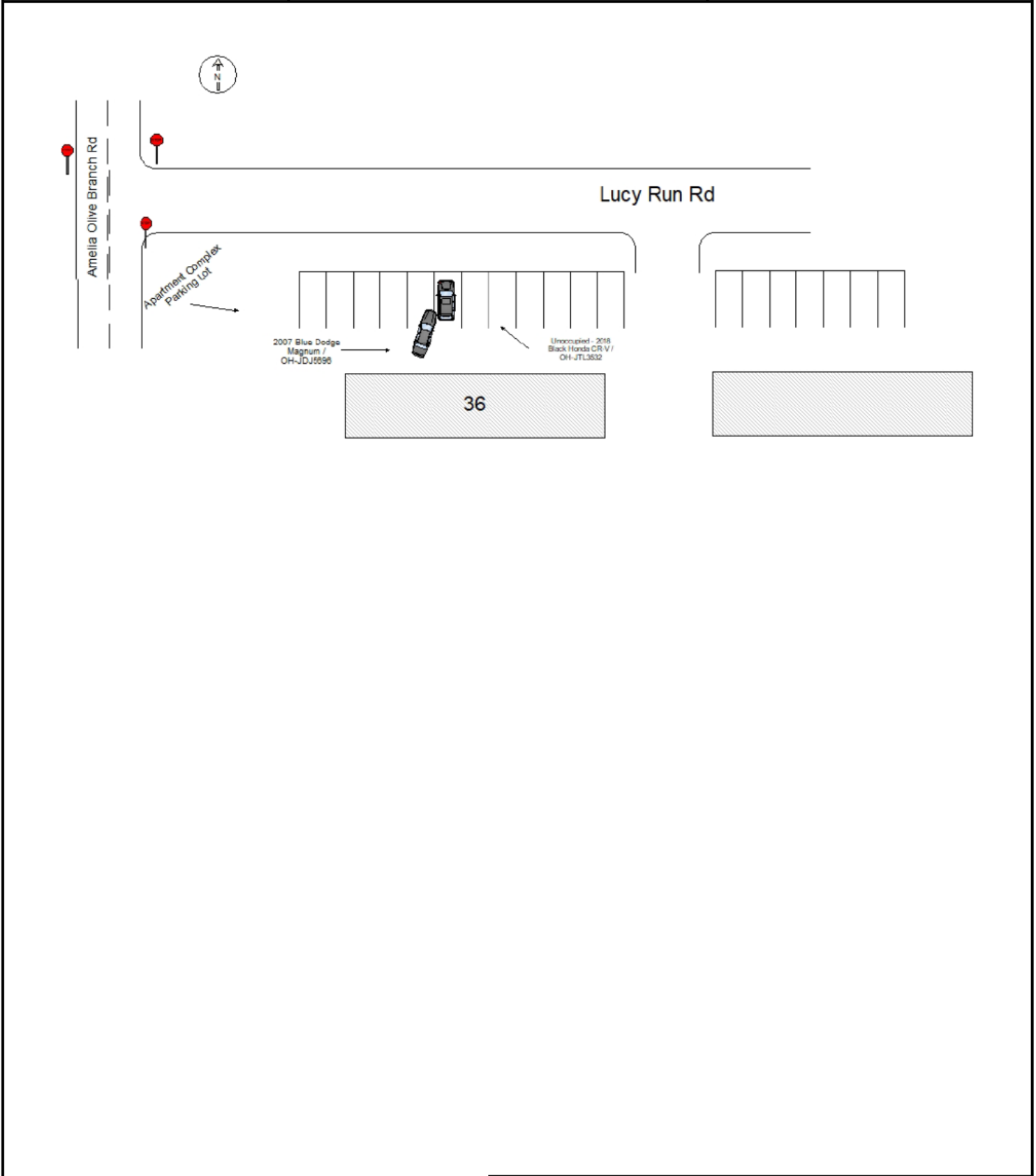
