NARRATIVE On 09/21/2025 at 1514 hrs. Unit 1, a black Toyota Corolla (OH KEX-3881) driven by Ms. Kylee Kidwell failed to negotiate a curve while driving on SR 222 North bound near the address of 3944 SR 222 in Batavia Twp. Clermont County Ohio. As Ms. Kidwell approached the 90 degree turn on SR 222, evidence appeared to indicate that she was traveling too fast for the wet road conditions and failed to negotiate the turn. Ms. Kidwell left the road right, hit a yellow turn indicator sign, went into the ditch, up the embankment, continued for 135 ft before regaining control of her vehicle and re-entering her lane of travel. I observed no skid marks in the roadway. Several road signs were damaged as was the right front of Ms. Kidwell's vehicle. Ms. Kidwell was transported by CJFED EMS to Clermont Mercy Hospital for evaluation.

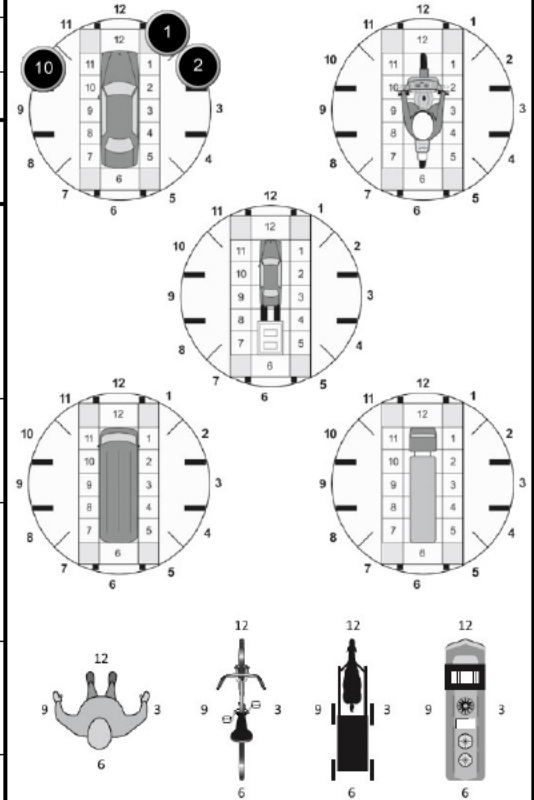

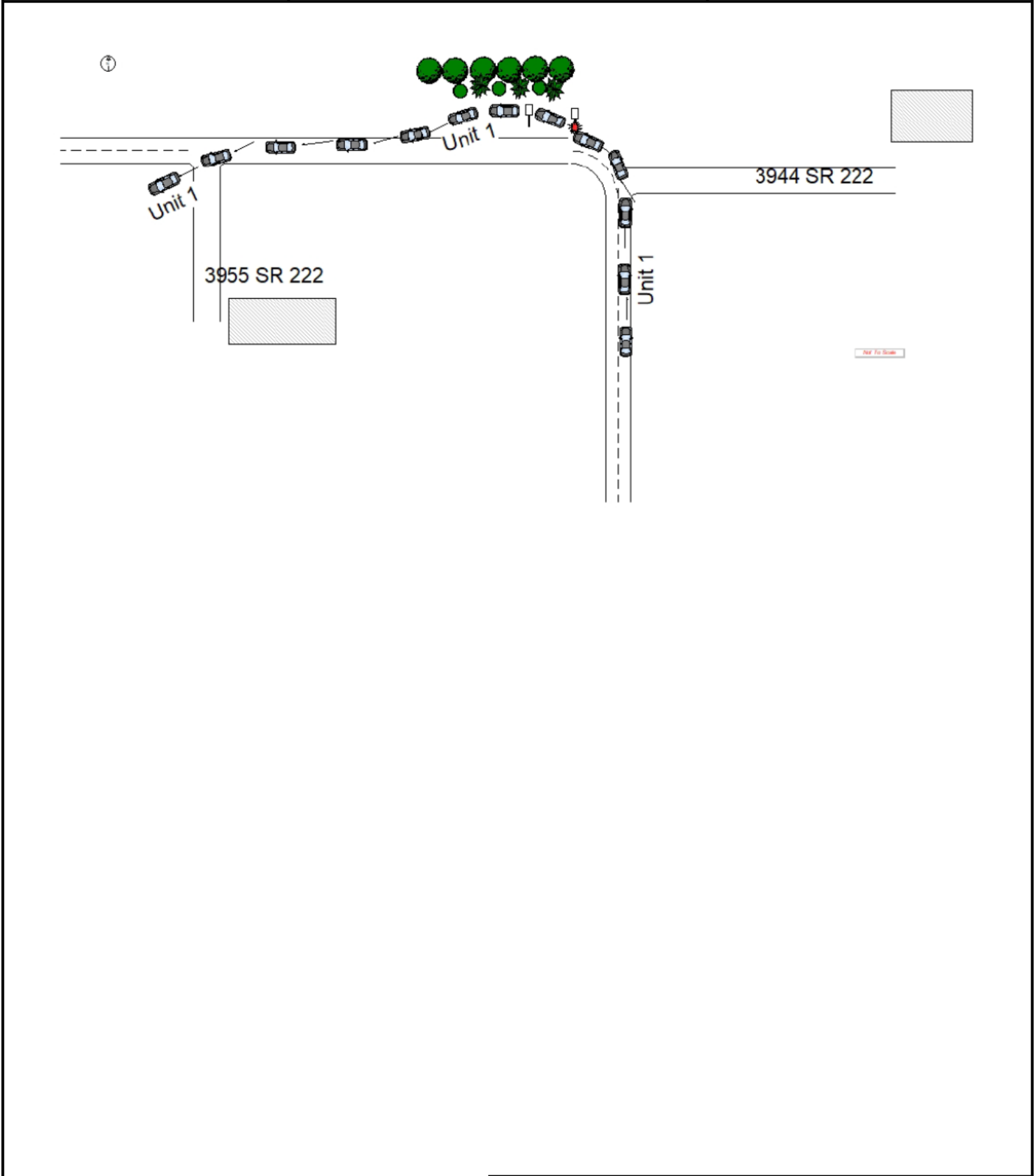
