Clermont County Ohio at approximately 1030 hrs. an unknown vehicle hit her parked 2012 Hyundai Accent in the left rear bumper/ rear quarter panel area causing damage. The unknown vehicle may have been white in color due to the apparent paint transfer on Unit 2's vehicle. It appears Unit 1 failed to maintain proper distance from a parked vehicle while attempting to turn into a parking spot, thus striking the left rear of Unit 2's vehicle with the front right of Unit 1. Unit 1 left the scene without reporting the accident. The accident was reported by the owner of unit 2 Ms. Natalie Bendgen on 10/04/2025.

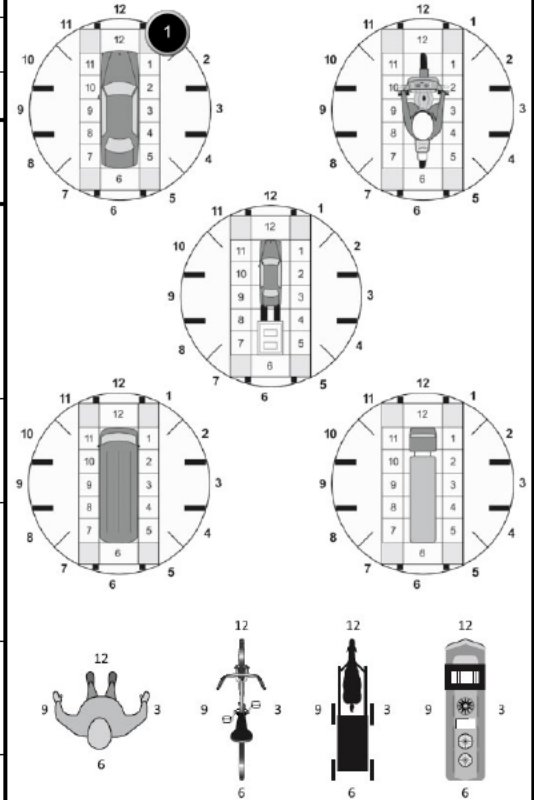

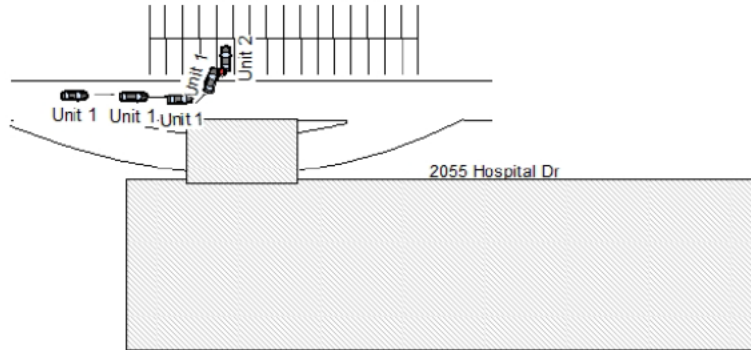
