On 10/14/2025 at 1759 hours, Unit 1 while sitting at the red light on Judd Rd and Amelia Olive Branch turned into the intersection before the intersection was clear of traffic, striking Unit 2 (Emily Rumley) who was traveling southbound on Amelia Olive Branch Rd. and turning left (EB) on Judd Rd. Unit 1 struck Unit 2 and caused damage to the left rear bumper, and left rear wheel. Unit 1 sustained disabling damage to a steering component of the vehicle and was towed by Tarvin Towing to Unit 1's (Ms. Karen Shepherd) residence. This accident occurred in Clermont County Ohio, Batavia twp.

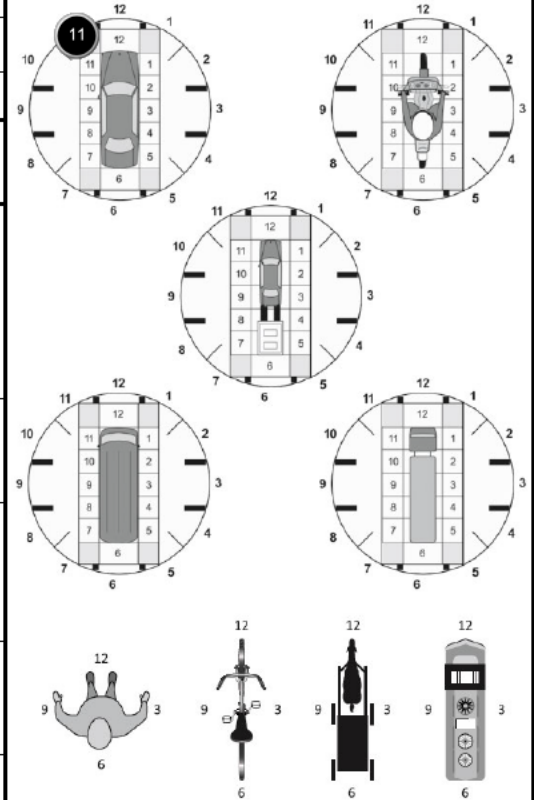

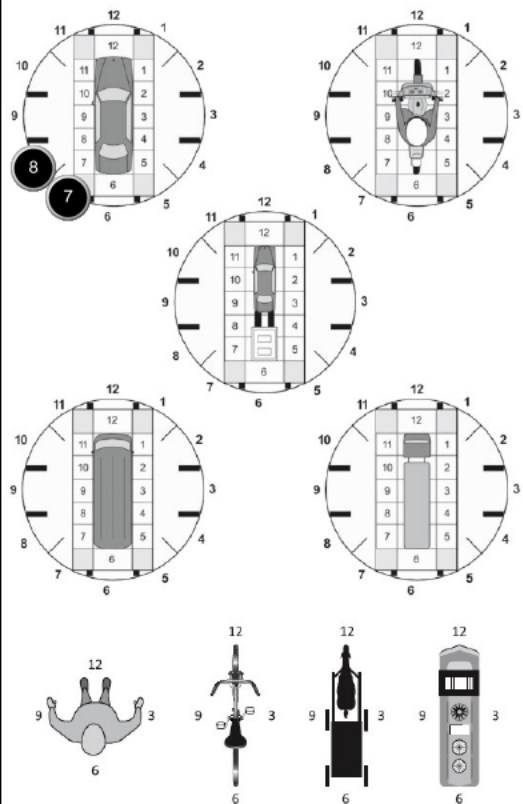

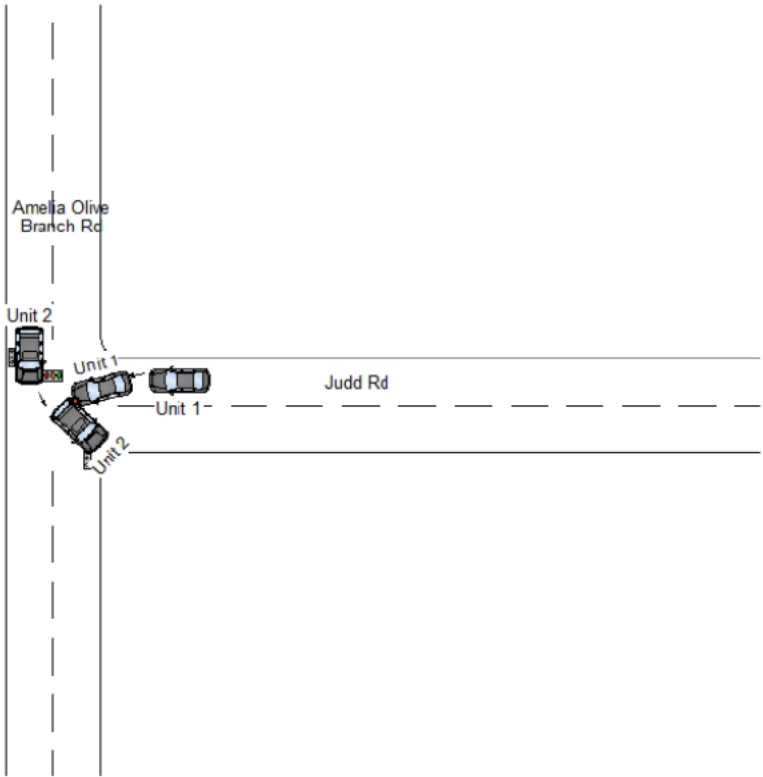
