NARRATIVE On 11/10/2025 I was dispatched to State Route 132 and Chapel Road in Batavia Twp for a 2 car MVA. Dispatch advised it was a Dodge Charger VS. GMC Envoy. Upon arrival at 1702 hours Deputies checked on occupants of the vehicle for injuries. Neither party had any injuries. Deputies cleared the roadway and were able to move both vehicles to a parking lot nearby to open the roadway back up. I spoke with both parties, Mr. De'Marcus Sutton who was in Unit #2 advised he was stopped at the intersection/stop sign waiting for his turn to go and all of a sudden his vehicle was struck. Mr. Sutton stated he was stationary and was facing West bound on Chapel Rd just before State Route 132. I then spoke with the other driver Ms. Amanda Louiso. Ms. Louiso stated she was heading North bound on State Route 132 and went to turn East bound on Chapel Rd and had struck another vehicle. Ms. Louiso stated she was bright lighted/flagged on by another driver allowing her to turn at the intersection. Ms. Louiso advised she did not see the other vehicle when she was making a left hand turn. Ms. Louiso was at fault and was issued a traffic citation for Failure to Yield. 4511.43. Ms. Louiso was unable to provide insurance for her vehicle.

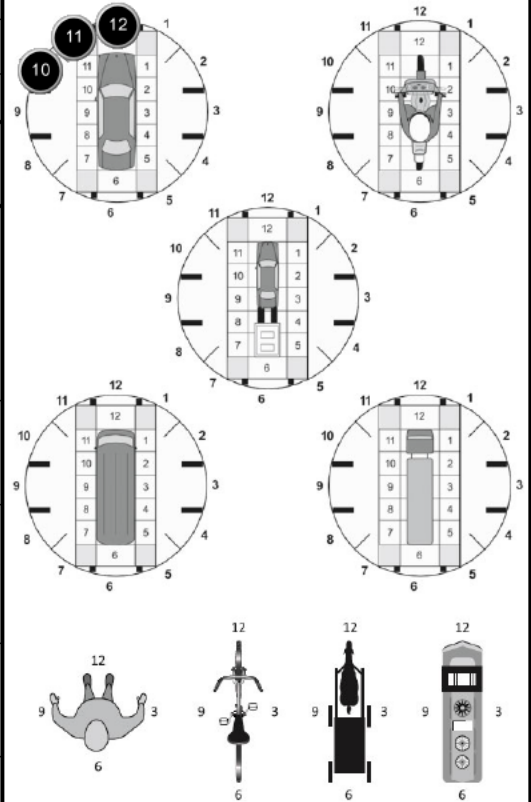

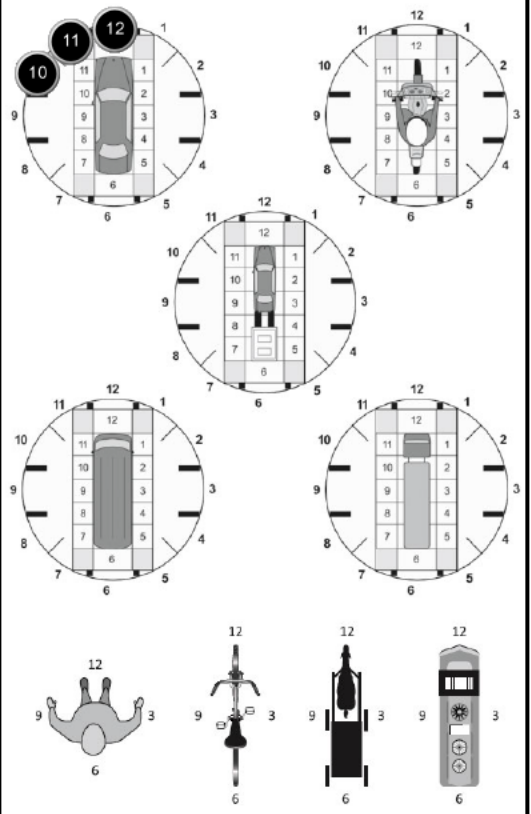

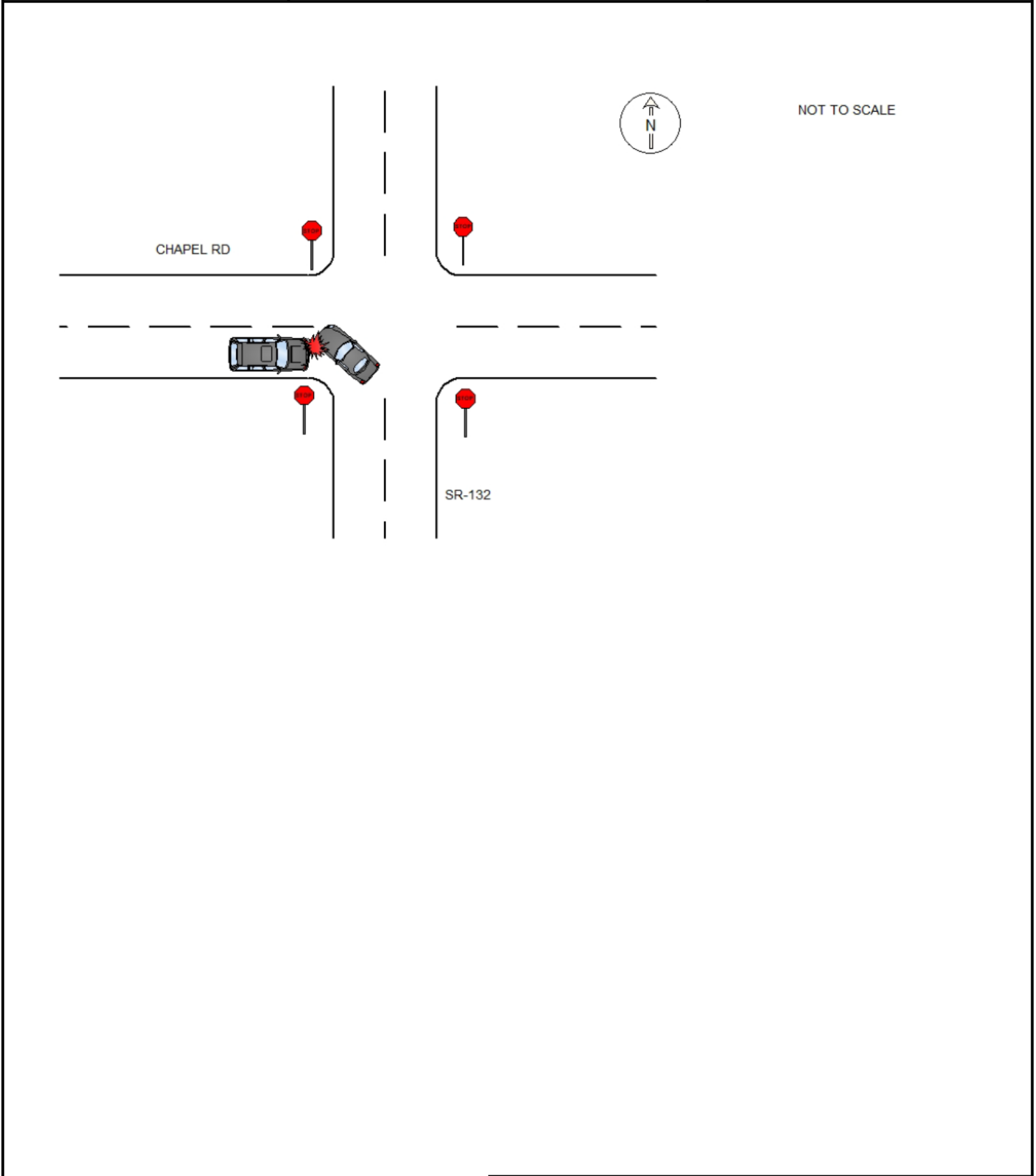
