NARRATIVE On 12/11/2025 at 0045 hours I was dispatched to the area of 1410 SR 133 in Franklin Township for an MVA with injuries. I arrived on scene at 0057 hours and made contact with the driver, Bralyn Blackburn, and front passenger, Zander Marlow, of a 2015 Kia Optima. EMS was on scene prior to my arrival and advised that both parties were refusing treatment. I spoke with Bralyn who advised she was traveling SB on SR 133 when she ended up losing control of her vehicle and struck a tree due to the snowy conditions. I observed heavy front end damage to the Kia and that all airbags has deployed. Bralyn was holding her stomach in pain and advised the steering wheel airbag had hit her in the stomach. I recommended to Bralyn to be checked out by EMS but she still refused. Zander had minor cuts to his hands and after looking at the vehicle's windshield I observed that it appeared Zander's head had shattered the glass. Zander confirmed but also refused to be treated by EMS. Photos were taken on scene. Vehicle was towed by Bethel Towing & Recovery.

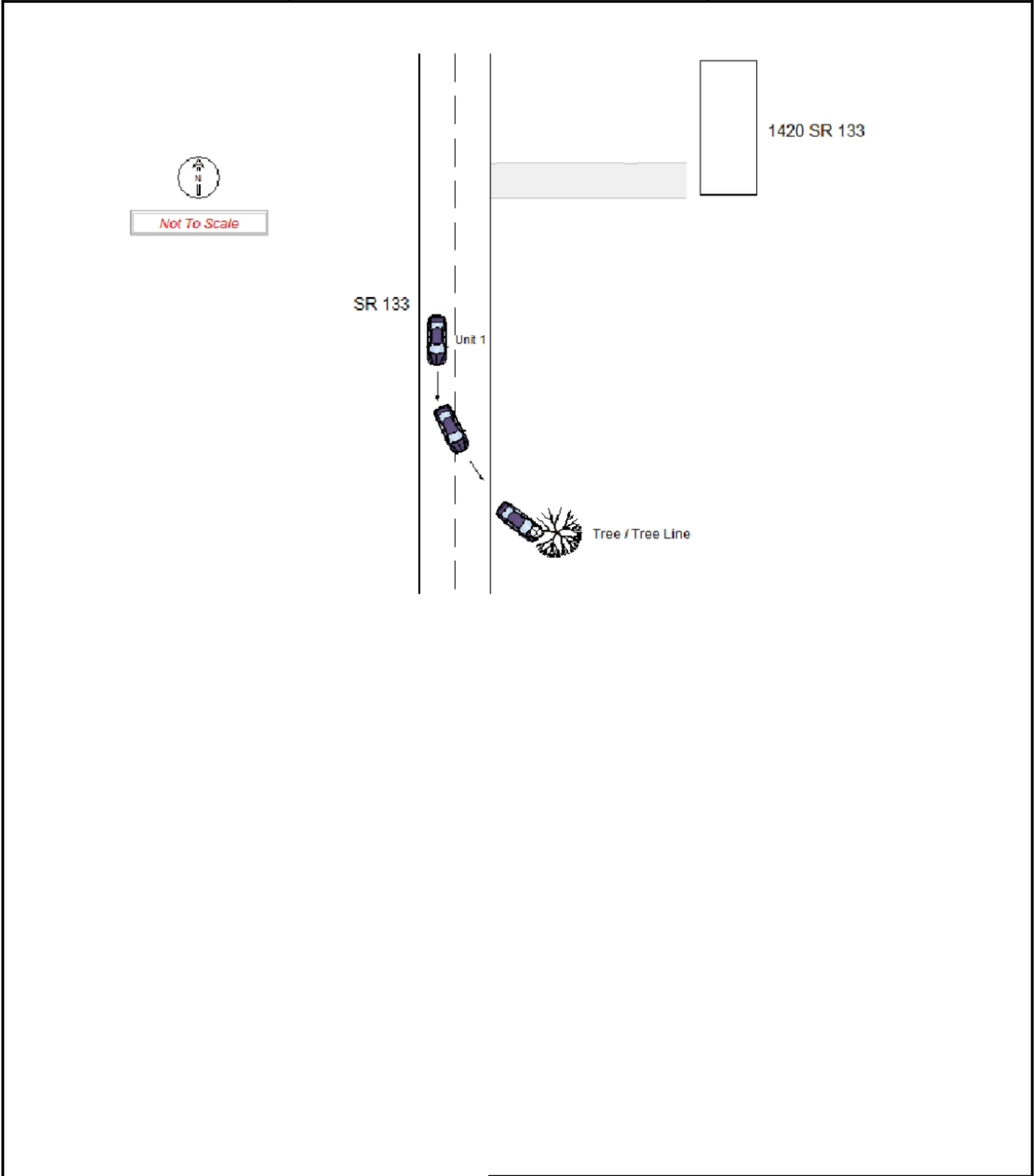
