NARRATIVE On 02/06/2026 at 0728 hours I was dispatched to the area of 2072 Laurel Point Isabel Road in Monroe Twp for a MVA. Dispatch advised there was a vehicle at this location that crashed and rolled over. Upon arrival at 0735 hours Monroe Twp Fire/EMS was already on scene and had the patient out of the vehicle Ms. Sheri L. Allen. Ms. Allen advised she was traveling West bound on Laurel Point Isabel Road and hit a patch of ice and drove off the roadway. When Ms. Allen drove off the roadway it caused her vehicle to catch the side of the road which put her into the ditch line then causing the vehicle to roll over onto it's top. Ms. Allen was unable to provide her insurance for her vehicle. Ms. Allen was cited for failure to control.

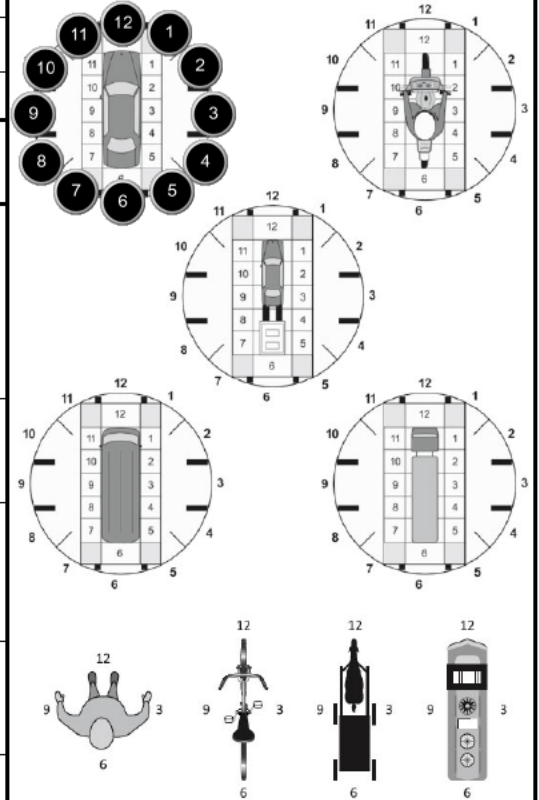

OHIO TRAFFIC ACCIDENT - OH2 DIAGRAM

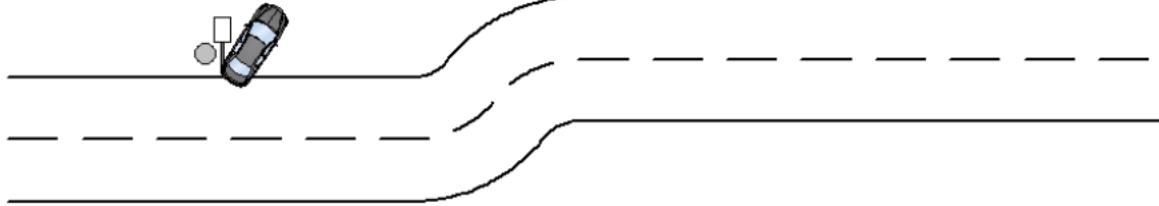
