NARRATIVE On 2/20/2026 at 1757 hours, I was dispatched to the area of SR 125 / Woodlands Dr in Batavia Township for a single vehicle MVA. The CAD notes indicated that it is a Jeep vs Pole. Upon my arrival, I observed a black Jeep Compass OH-KKQ9601 with heavy front end damage along with heavy damage to the Duke Electric Pole. I observed fluid running from the vehicle and all airbags deployed. The sole occupant / driver was identified as Ms. Angela Irwin. Medics arrived on scene and spoke with Angela who did not appear alert. While on scene it was discovered that Angela suffered from a diabetic emergency and her blood sugar was at 49. After Angela was given medication she became alert. Angela advised she did not remember what happened and did not know she struck a pole. I spoke with a witness on scene who advised she observed Angela veer of the road onto the sidewalk before striking the pole. Angela was transported to Clermont Mercy Hospital and her vehicle was towed by L Wood & Sons.

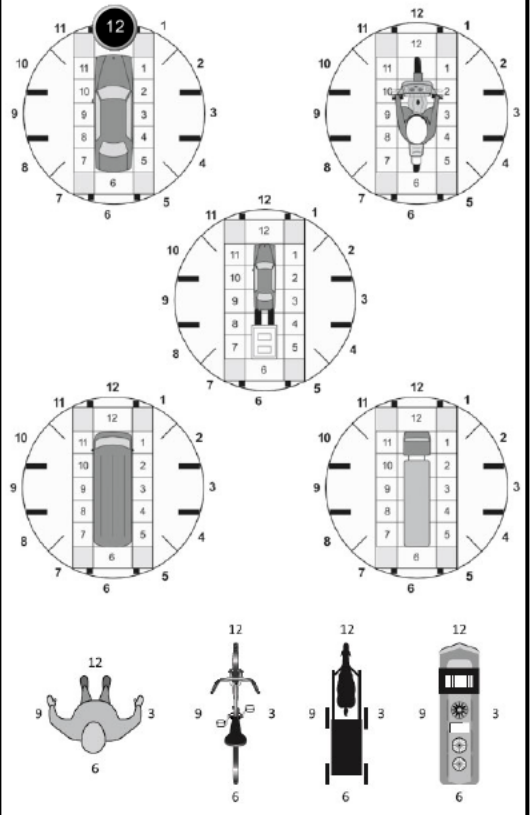

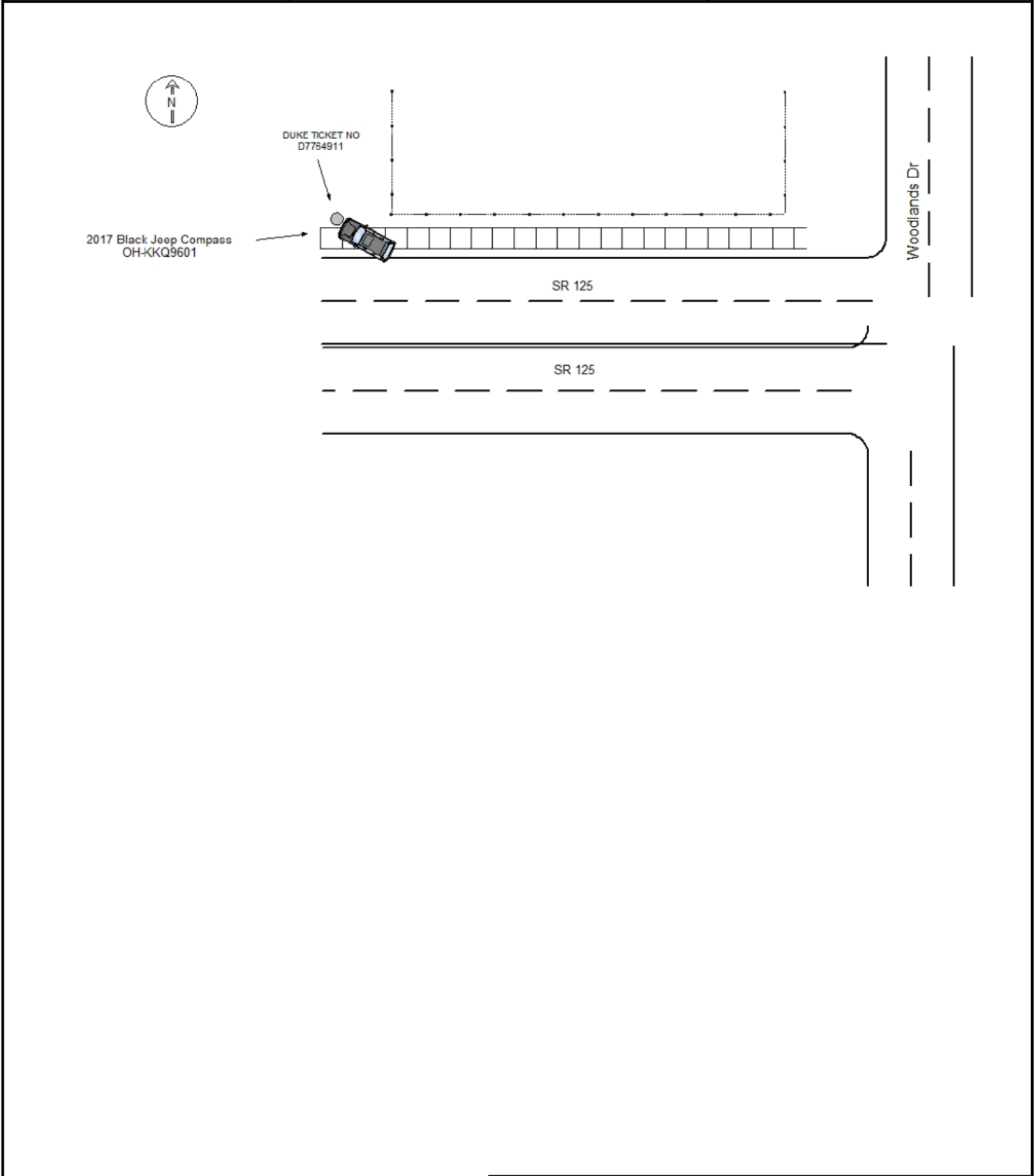
