Main St. Unit 2 was the lead vehicle traveling at the speed limit in the left lane of travel. Unit 1 passed unit 2 on the shoulder not in a lane of travel. Once unit 1 was in front of unit 2 unit 1 slammed on the breaks causing unit 2 to lose control which then caused unit 3 to hit unit 2 and unit 4 to hit unit 3. Unit 2 has a dash camera that captured the incident. In the video unit 1 is a large black SUV. Unit 1 is seen passing unit 2 on the shoulder and then break checking unit 2. 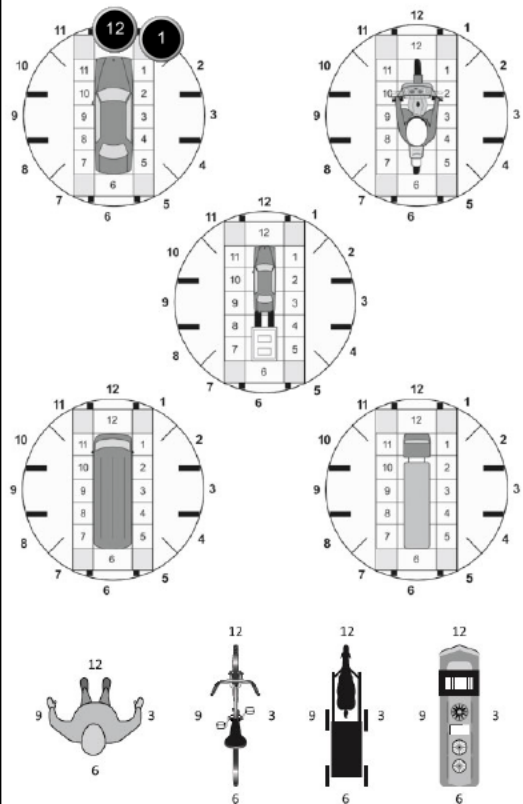
