Mr. Helbling stated when he got over his tires caught the edge of the roadway forcing him into the ditch.

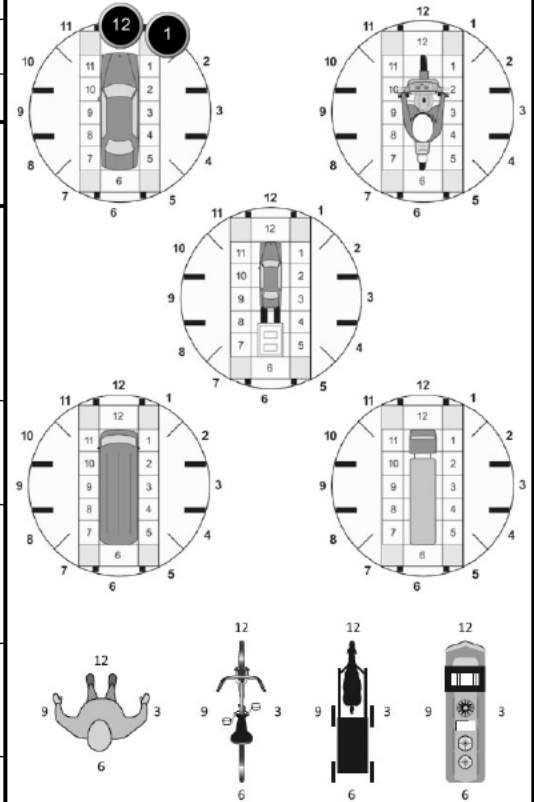

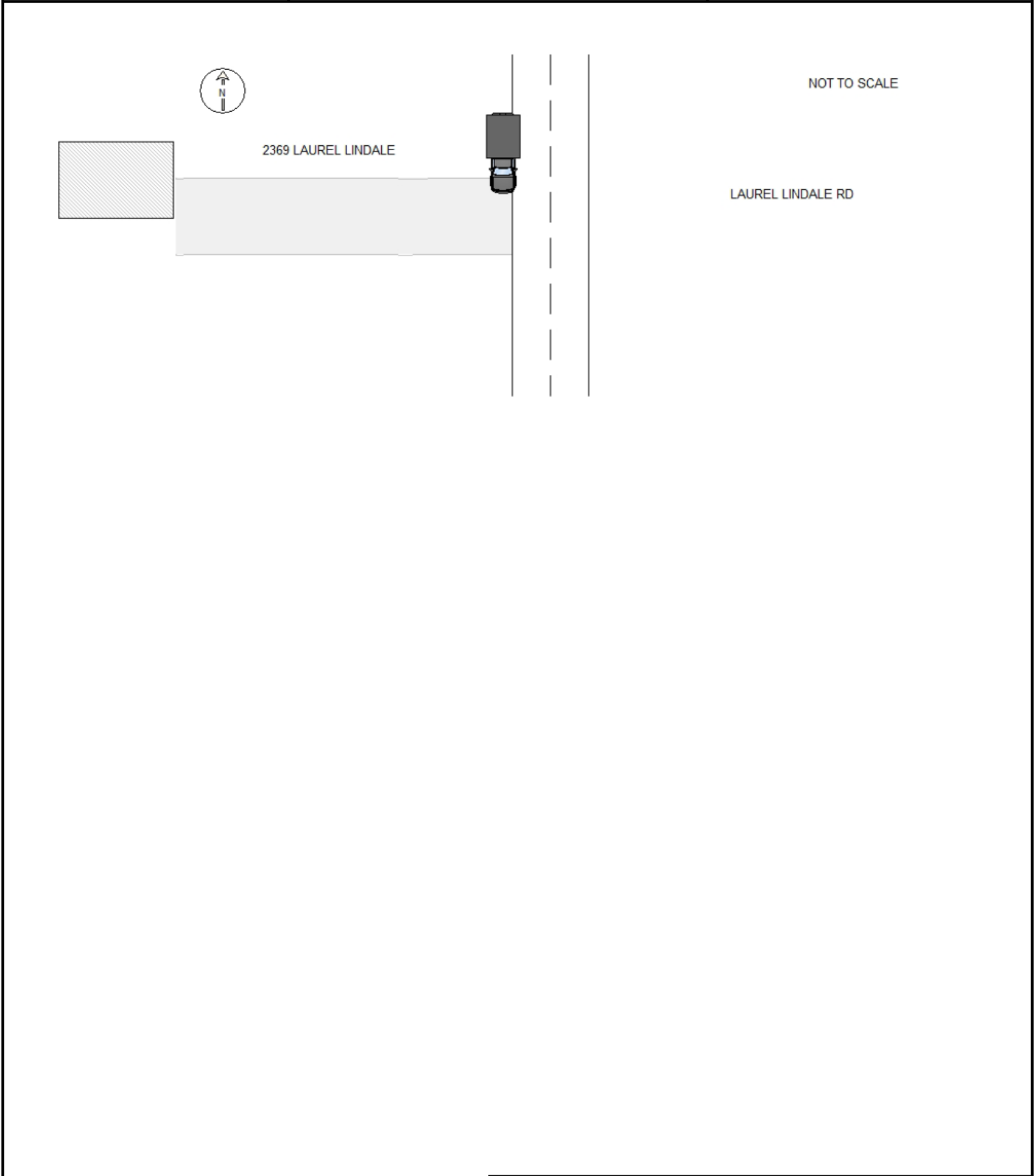
