

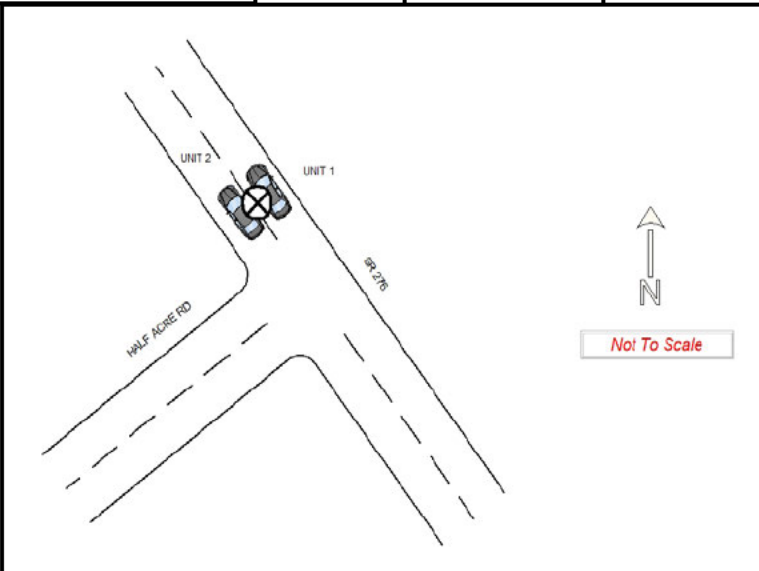

Unit 1 claimed Unit 2 swerved into his vehicle and Unit 1 claimed Unit 2 passed too closely and struck his vehicle. Both vehicles displayed similar levels of damage and had left the scene before reporting the accident occurred. Neither unit could be reliably determined to be at fault, as both claimed the other was at fault with no physical evidence to confirm or deny either of the versions.

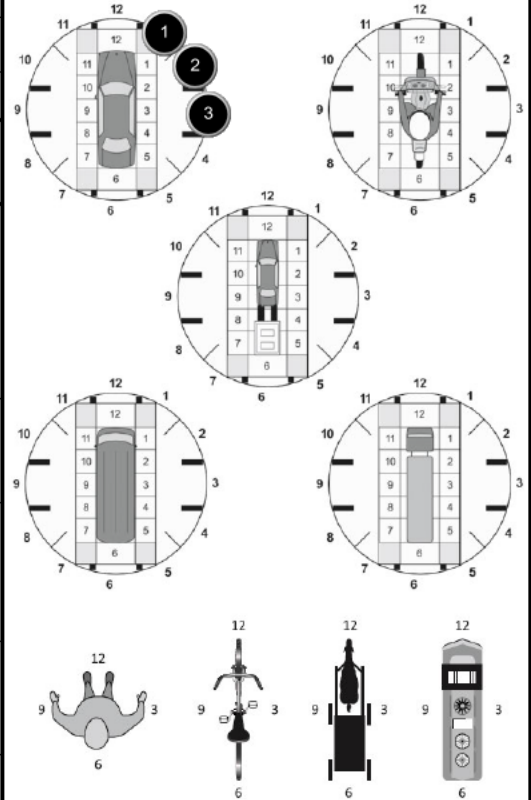

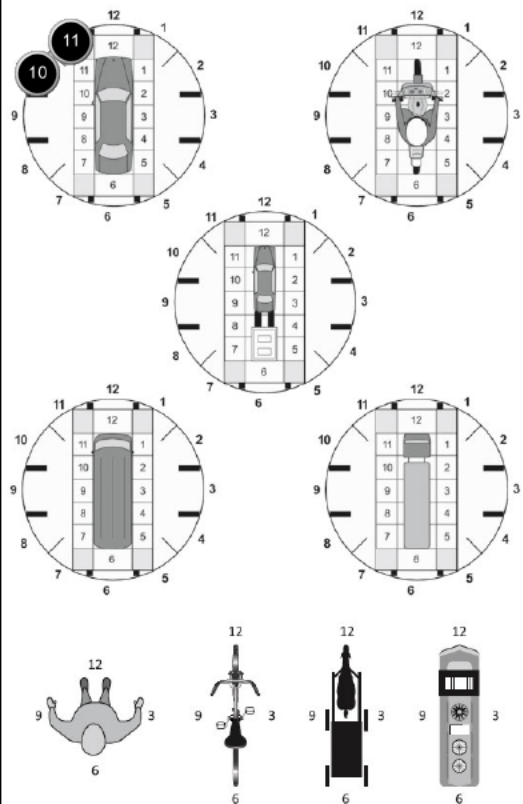

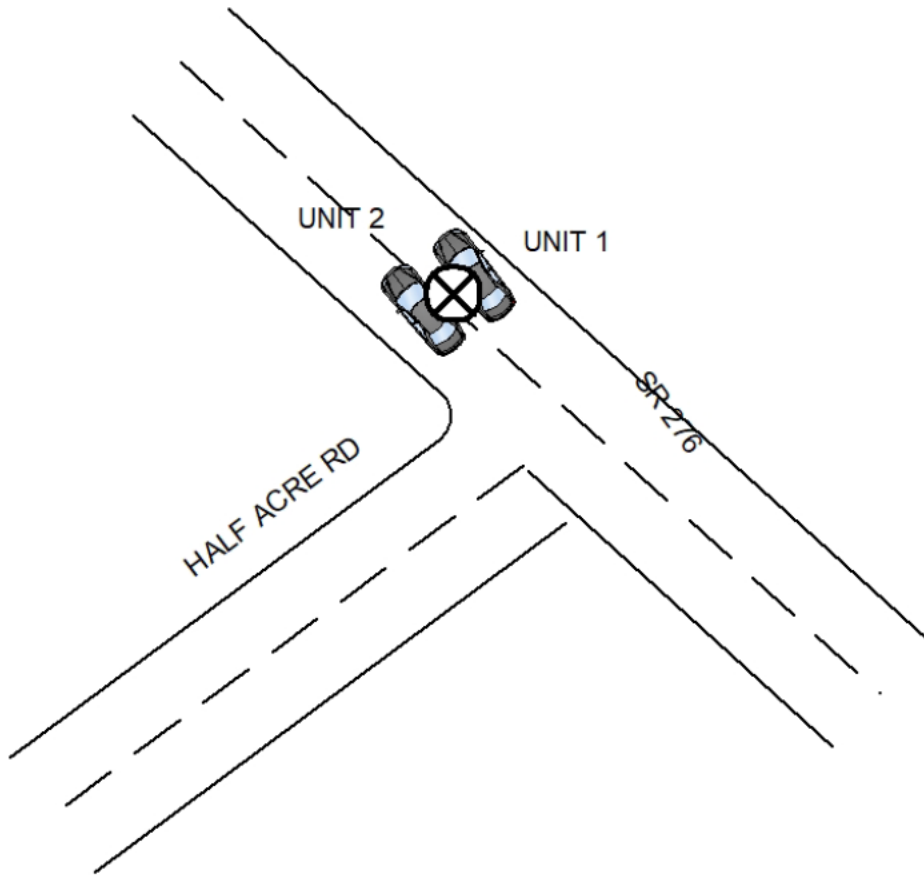
