Upon my arrival, I discovered Unit #1 being a silver Jeep SUV and Unit #2 being a black Toyota sedan. The occupants of the Jeep were identified as Ms. Bobbie Schwartz (Driver) and FS (rear seat passenger). The sole occupant of Unit #2 was identified as Mr. Steven Peskin. All parties denied having any injuries I observed damage to the front driver side of both vehicles. Upon speaking to the parties involved it was determined that Mr. Peskin was at the stop sign oat the intersection of Southcross Dr / Crossridge Dr. Ms. Schwartz was turning left from Crossridge Dr onto Southcross Dr. While turning left Ms. Schwartz stuck the front driver side of the black Toyota sedan. I obtained photographs at the scene and obtained information from both parties. The Silver Jeep SUV was disabled in result of the crash. L Wood & Son Towing Company responded to the scene and towed the Jeep away.

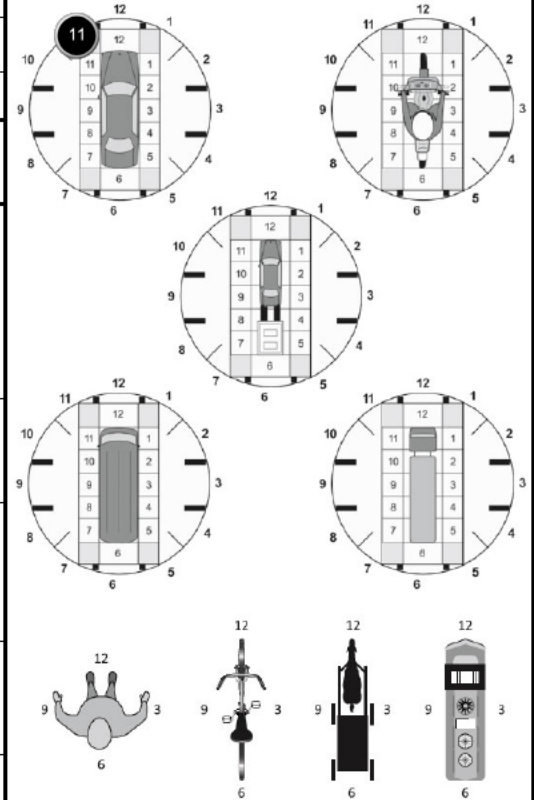

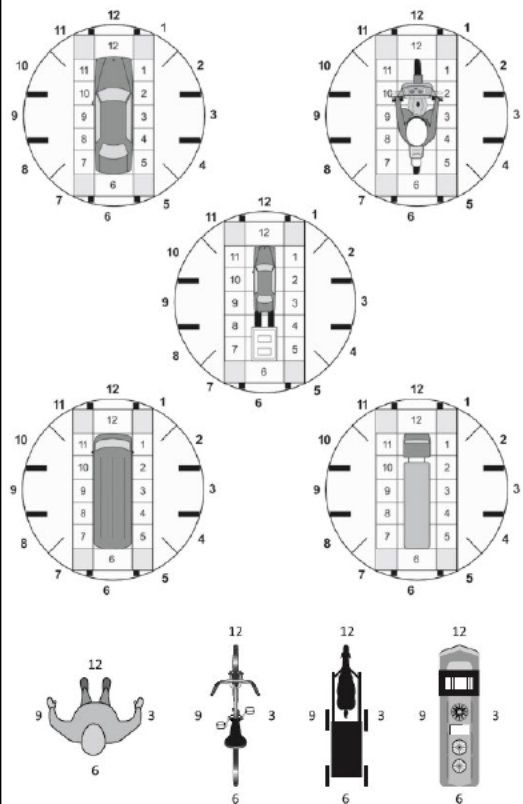

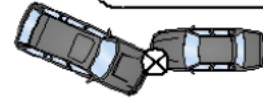
