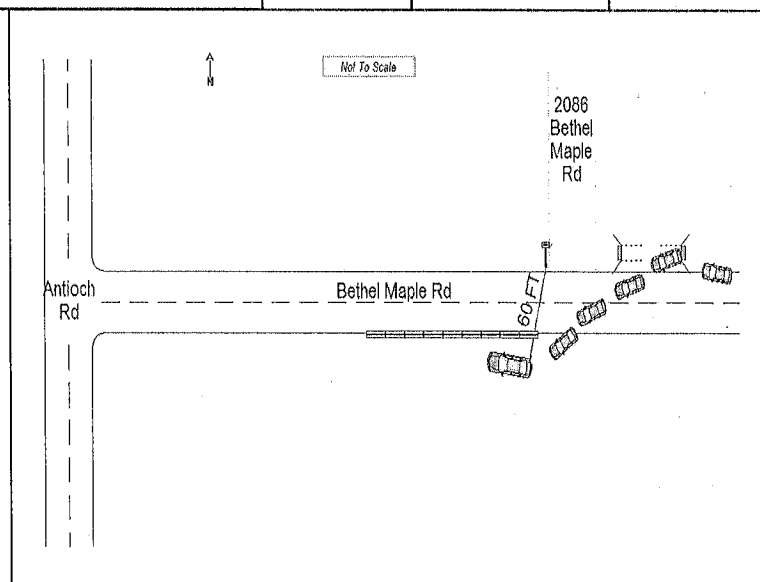

NARRATIVE

On March 13, 2021 at 2358 hours, I responded to the area of Bethel Maple Rd / Antioch Rd in Tate Township for a MVA. The caller, Mr. Doug Purtee (2086 Bethel Maple Rd) advised their was a single vehicle MVA with no injuries. Upon arrival, EMS (Bethel- Tate) & Fire were on scene. I observed a tan Buick with Ohio Registration - 594YVA down a slight embankment and rested behind a guardrail. The vehicle was located directly across the street from Mr. Purtee's residence. After the driver was cleared by EMS personnel, I began speaking to him by my cruiser. The driver was identified as Mr. Randy Reynolds. Mr. Reynolds explained to me that he was traveling WB on Bethel Maple Rd. Mr. Reynolds advised while traveling WB he observed a rock in the roadway and swerved in attempt to avoid striking the rock. Mr. Reynolds advised he went off the roadway to the right hitting a culvert, back onto the roadway, left of center, off the roadway to the left, then down the embankment. I observed heavy damage to the culvert located on Mr. Purtee's property. While speaking to Mr. Reynolds, I did not detect any odor of an alcoholic beverage emitting from Mr. Reynolds person. I took Mr. Reynolds through the field sobriety test and did not detect any drug / alcohol impairment. Mr. Reynolds was issued a citation for driving under suspension (OVI) and operation without reasonable control.

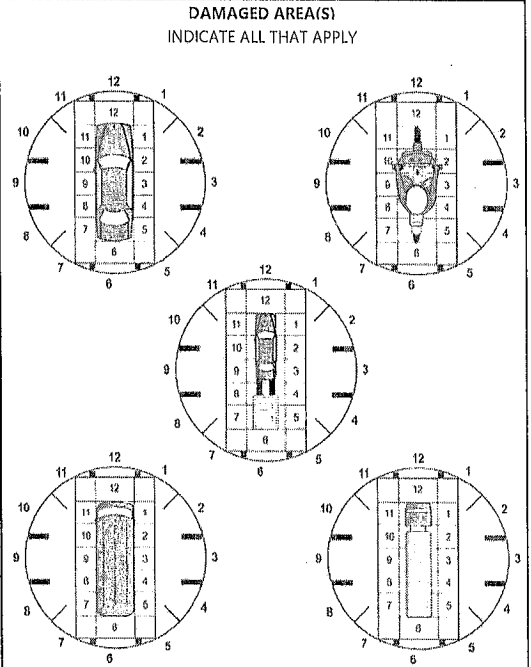

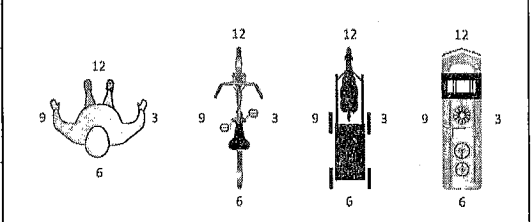

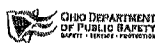
