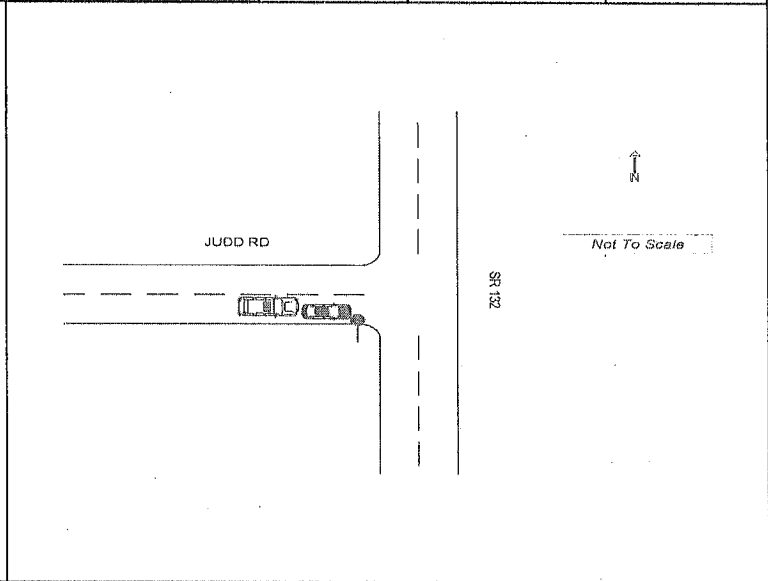

NARRATIVE
On March 23rd, 2021, at 1933 hours, I was dispatched to the intersection of SR 132 & Judd Rd., Batavia Township for a two car MVA. Dispatch advised no injuries. When I arrived on scene, I made contact with the driver of Unit 1, Tabitha Millis, who advised she saw someone approaching her from the rear at a high rate of speed so she moved her vehicle forward to avoid being hit when she struck Unit 2. She advised both vehicles were at the stop sign on Judd Rd and were preparing to enter SR 132.
