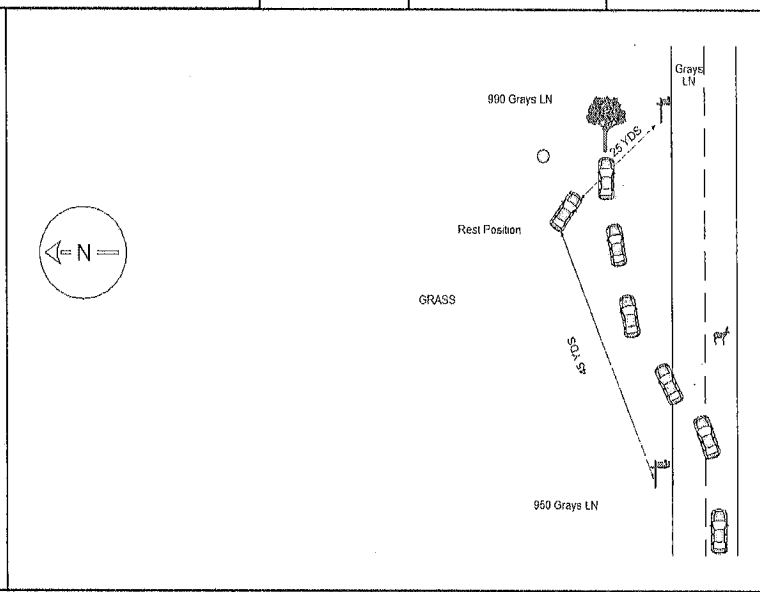

NARRATIVE

On May 19th, 2021 at 0011 hours, I responded to a single vehicle MVA near 990 Grays Ln in Ohio Township. The CAD notes advised "COMPL ADV HE HEARD A CAR CRASH AND SOUNDS LIKE YOUNG KIDS CALLING FOR HELP - CANT SEE ANYTHING BUT JUST HEARD IT- SOUNDS LIKE THERE COULD BE INJURIES". Upon my arrival, I located a white Saturn Sedan (OH- JHH6791) in the front yard of 990 Grays Ln with front in damage. The vehicle was approximately 25 yards from the mailbox (reference Point). I observed tire marks coming from the west towards the east. The tire marks started on the roadway, left of center into the grass and towards the tree located next to the mailbox. I observed tree bark missing from the tree and tree bark in the front end of the vehicle. I made contact with a female on scene. She identified herself as Ms. Amanda Shuemaker. Ms. Shuemaker advised she was the only occupant in the vehicle. Ms. Shuemaker advised she was traveling EB on Grays Ln when a deer ran out onto the roadway. Ms. Shuemaker advised she swerved to the left and off the roadway to prevent herself from hitting the deer. Upon running Ms. Shuemaker's information through LEADS / NCIC she was showing Suspended. Ms. Shuemaker was issued a citation for DUJ. The vehicle was towed by Nicholasville Towing. Deputy B. Pham #12228

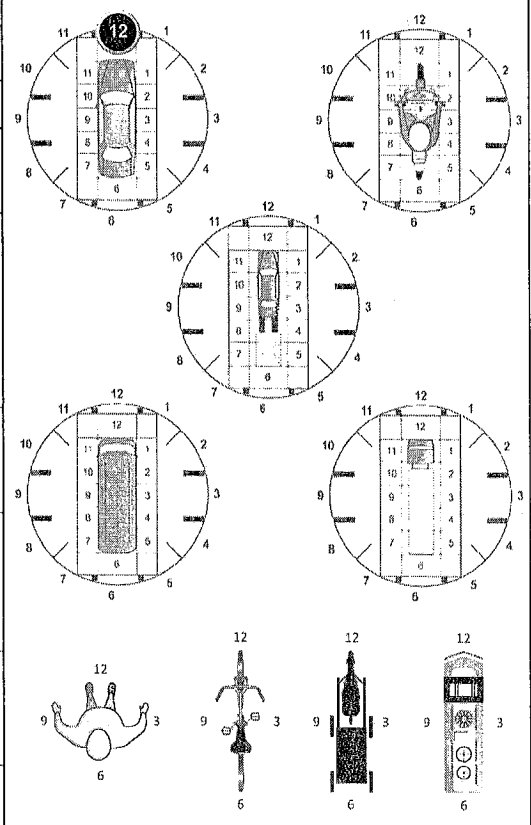
