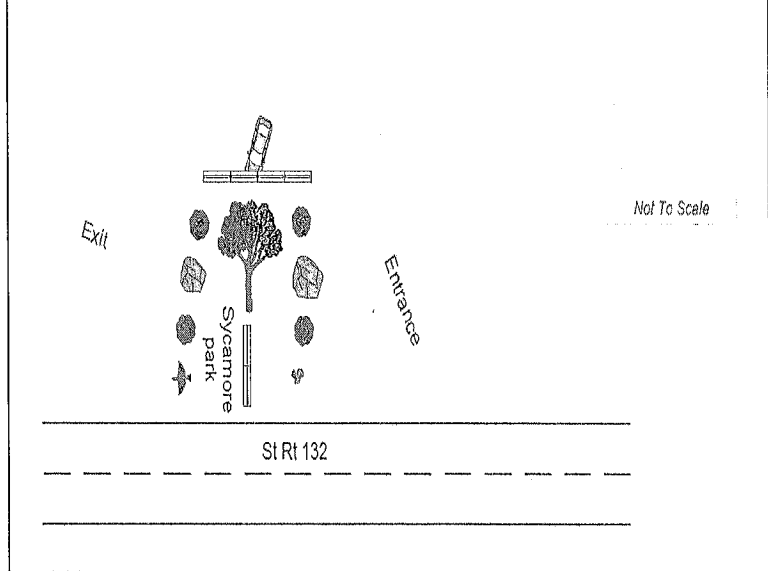

Unit 1 was driving up the hill to the exit of Sycamore Park at 4082 St Rt 132 when he lost control and hit the retaining wall in the center of the entrance and exit. Unit one male driver was impaired and not able to stand up. Unit 1 front end was severely damaged along with the retaining wall. Unit 1 passenger had facial injury. Joint Central EMS responded to check on the injury of Unit 1 passenger. Unit 1 passenger refused transport. Unit 1 stated he slid across the exit while driving on a toy tire. Danbury's towing came and towed the vehicle. Unit 1 stated he was only going about 20 MPH.

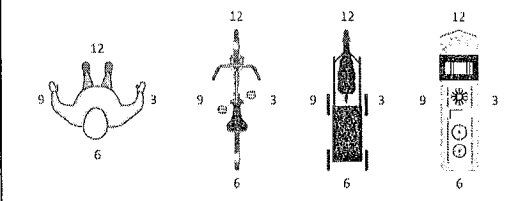
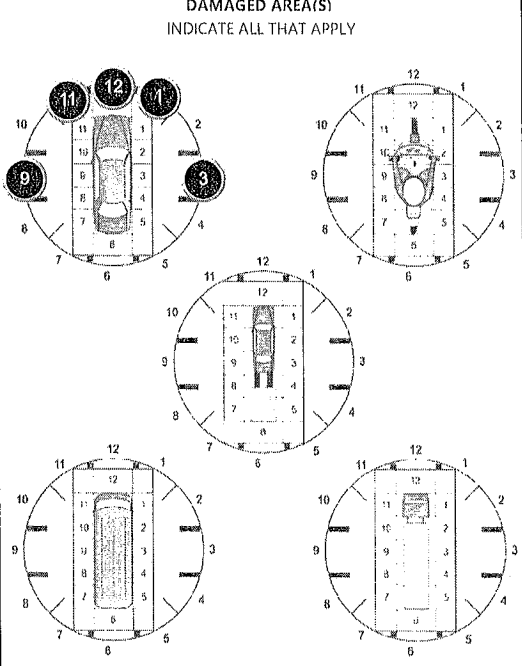
