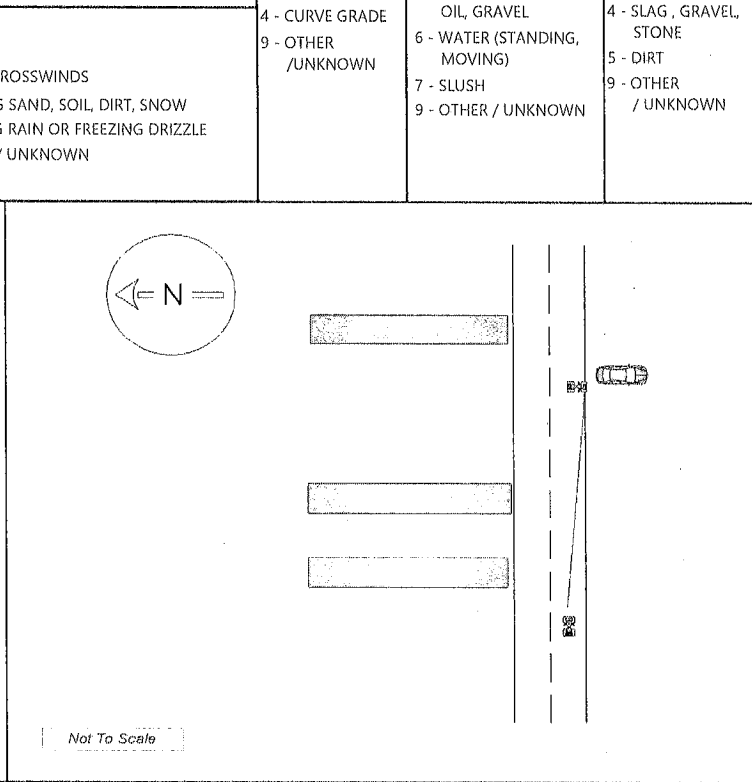

**NARRATIVE**

While enroute I contacted Pierce Twp. EMS, they advised that Mr. Taulbee had appeared to have significant brain injury.
