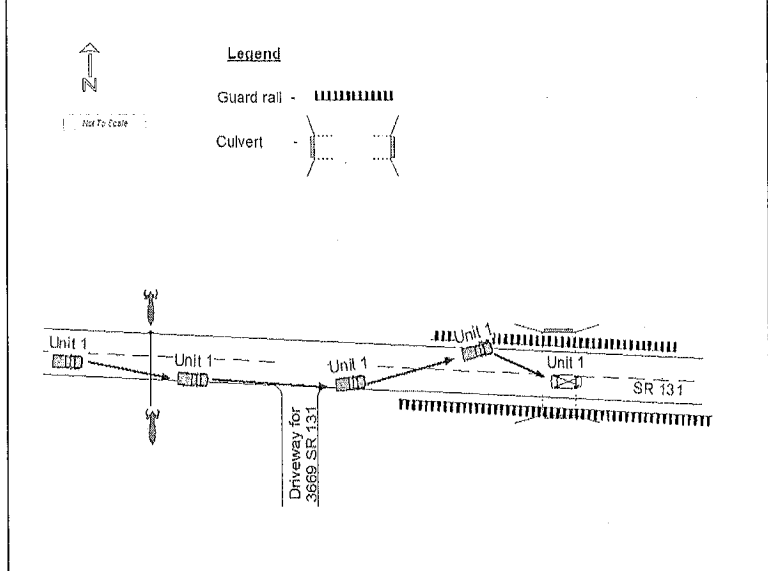

 Unit 1 was traveling east bound on SR 131. A deer ran across SR 131 from south to north just west of 3669 SR 131. Unit 1 swerved right to avoid the deer and the tires on the right side of the vehicle left the roadway. Unit 1 over corrected, reentered the road, crossed both lanes of travel and struck a guard rail on the north side of SR 131. Unit 1 bounced off the guard rail, rolled over and came to rest on its top in the middle of the roadway.

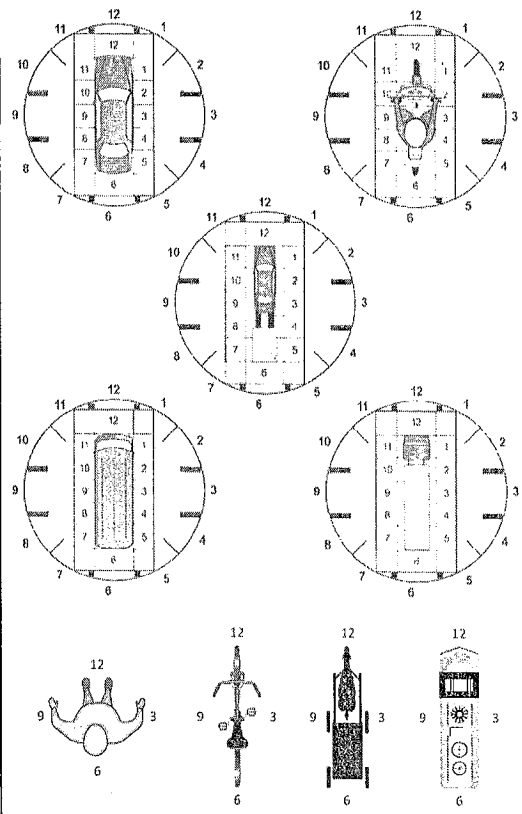

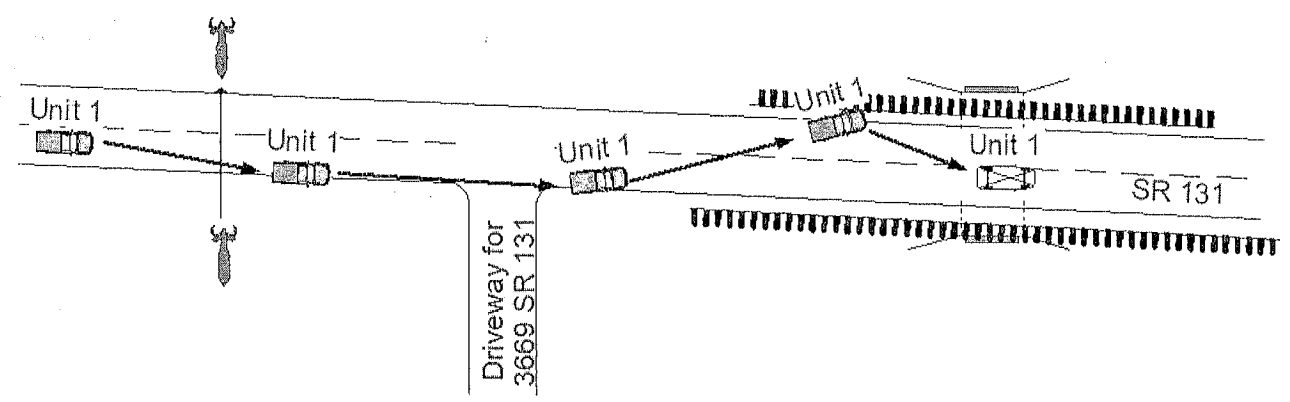
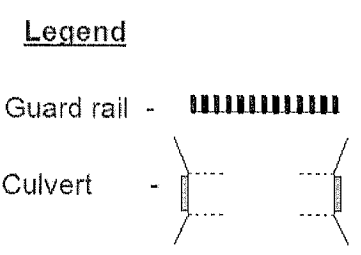
