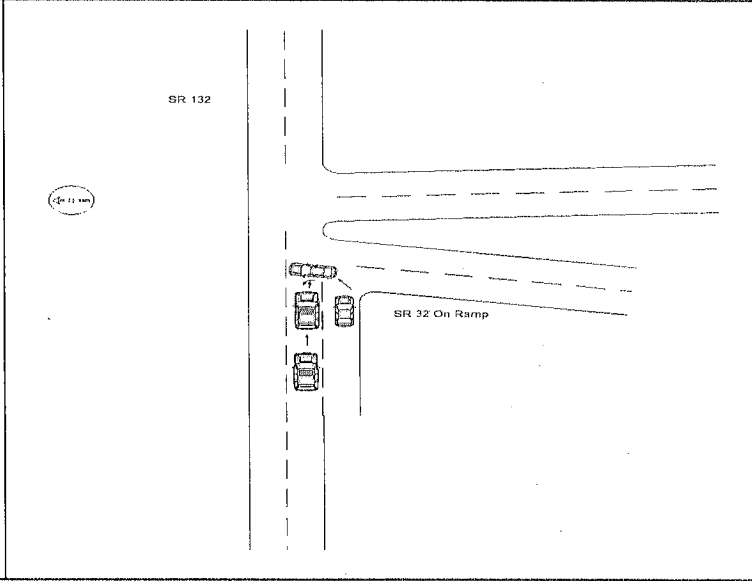

**NARRATIVE**

On September 8, 2021, I was dispatched to the area of SR 132/ SR 32 on ramp for a two vehicle accident with no injuries. Upon arrival both vehicles had moved to the side of the road to allow traffic flow. I spoke with the driver of Unit 1 Lena Johnson. Ms. Johnson stated she was traveling east on SR 132 from SR 222. While approaching the intersection Ms. Johnson stated she observed a black sedan sitting in the turn lane to enter SR 32. Before passing the vehicle Ms. Johnson stated the black vehicle pulled in front of her in an attempt to make an illegal U-Turn causing her to strike the vehicle as it was turning around. I then spoke with the driver of Unit 2 Sarah Hernandez. Ms. Hernandez stated she was in the turn lane to enter SR 32 when she realized she was going the wrong direction. Ms. Hernandez stated she looked at the lanes in front of her but forgot to look in the lane next to her as she attempted a U-Turn. Ms. Hernandez acknowledged that she could not do a U-Turn at this spot in the roadway and stated she just did not see the vehicle coming from the same direction she was facing. Both vehicles airbags deployed and were towed from the scene.

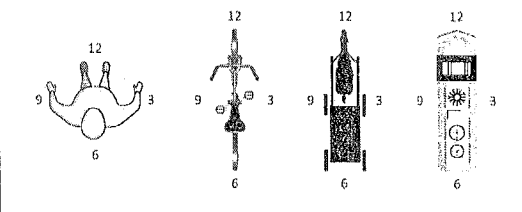
