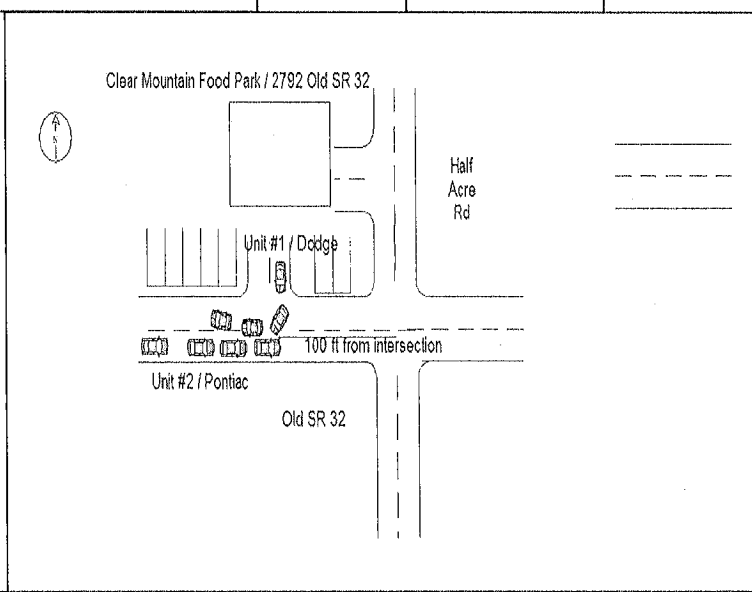

NARRATIVE
 On September 10, 2021 at 2030 hours, I was clearing a call located at 2781 Old SR 32 in Williamsburg Township. While walking back to my cruiser I heard a loud crash nearby. I walked over to the crash located on Old SR 32 and 2792 Old SR 32 (Clear Mountain Food Park). The crash was a 2 vehicle MVA with Unit #1 being a 1984 black 4-door Dodge and Unit #2 being a 2005 Maroon HB Pontiac. I checked on the driver of unit #1, Mr. David Beckstedt who advised he was okay and not injured. I then asked for his identification and proof of insurance. Mr. Beckstedt was unable to provide proof of insurance and advised his insurance just expired. I then checked on the driver of Unit #2, Mr. James Barringer Jr. Ms. Baringer provided me with his identification and proof of insurance. Ms. Barringer advised that he was having pain in his lower back in result of the accident, however denied for a squad to respond. I asked Mr. Baringer multiple times if he wanted a squad to respond, he stated "no" each time. Mr. Barringer advised he was traveling EB on Old SR 32 when Mr. Beckstedt was pulling out of the Clear Mountain Food Park onto Old SR 32. When Mr. Beckstedt was pulling out, he cross the double yellow line while turning and struck the driver side of Mr. Barringer's vehicle. I observed heavy damage along the driver side of the vehicle from the driver side door to the rear bumper.

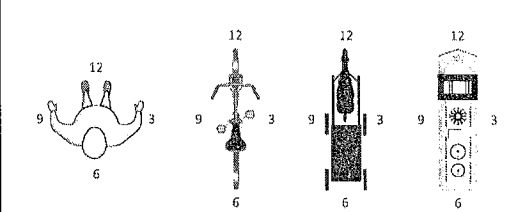
