NARRATIVE On September 25, 2021 at 2235 hours, I was dispatched to the area of 1330 Deer Ridge Estate Drive in Ohio Township for an MVA with injuries. The CAD notes indicated that it was a single vehicle vs tree. Prior to my arrival, the injured juvenile Isabella (15YOA) was transported to Cincinnati Children's Hospital by New Richmond EMS. Isabella's mother, Ms. Lisa Couch responded to the scene and followed the squad prior to my arrival. Upon my arrival, I observed a chrome Honda Ridgeline Truck (OH-DKW3023) head on with a tree located off the roadway on the property of 1330 Deer Ridge Estate Dr. I observed heavy front end damage to the vehicle with both front airbags deployed. I made contact with the driver, Benjamin (17YOA). Benjamin explained to me that he was traveling SB on Deer Ridge when he ran of the roadway to the left and struck the tree head on. I did not observe any lights on the roadway, marks in the roadway, or any reflectors on the roadway. Benjamin advised he was not distracted and stated "I blinked and next thing I know I hit the tree. I made contact with Benjamin's father, Mr. Matthew Schuster while on scene. Mr. Schuster is the R/O and called for a tow truck (AAA). I called Ms. Couch and requested for her to take pictures of any injuries that Isabella had sustained from the accident and email them to me. Photographs were taken at the scene.

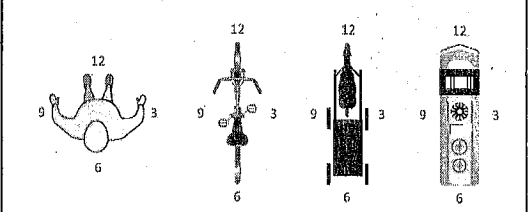
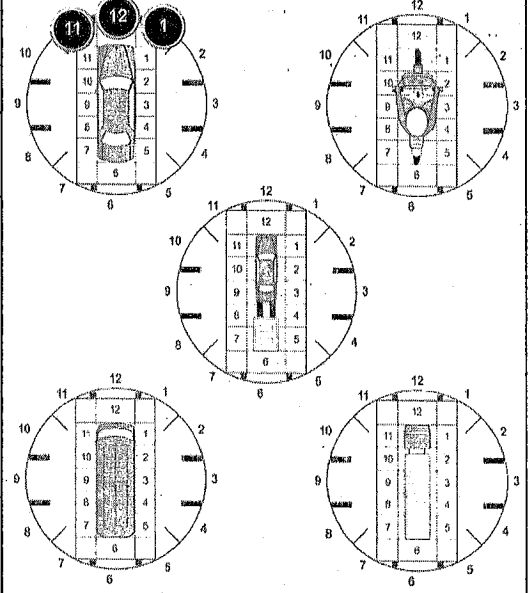

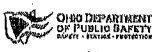
