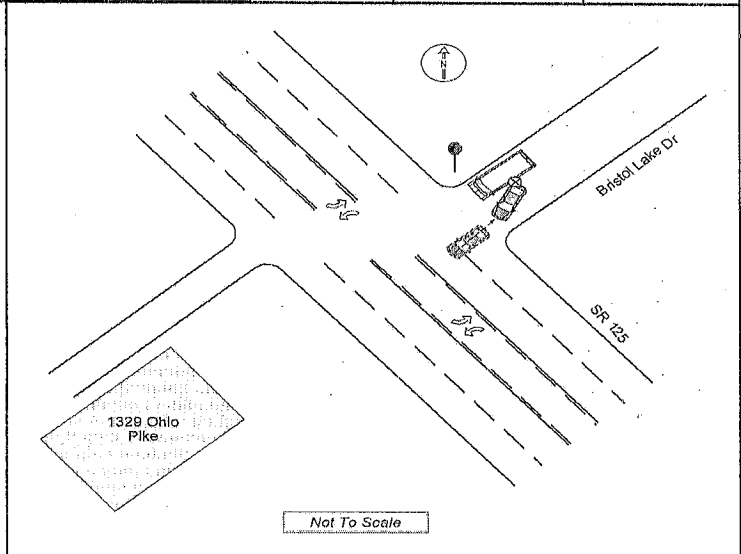

NARRATIVE
On December 4th, 2021, at 1433 hours I was dispatched to the area of SR 125 & Bristol Lake Dr. for a non-injury crash. Dispatch advised that one of the driver's (Unit 1) was "very irrational and trying to run over the other driver" but had now seperated. When I arrived on scene, I made contact with the driver of Unit 1, Christopher Kania. Mr. Kania advised that he was pulling out onto SR 125 to head eastbound but he did not feel safe to enter traffic. He advised that he began backing up to return back onto Bristol Lake Dr when he backed into Unit 2. The driver of Unit 2, Mark Potts, advised the same. Mr. Potts advised that Mr. Kania became irate and began causing a disorder. Based on the above statements and the manner of the crash, Mr. Kania was cited for Improper Backing.

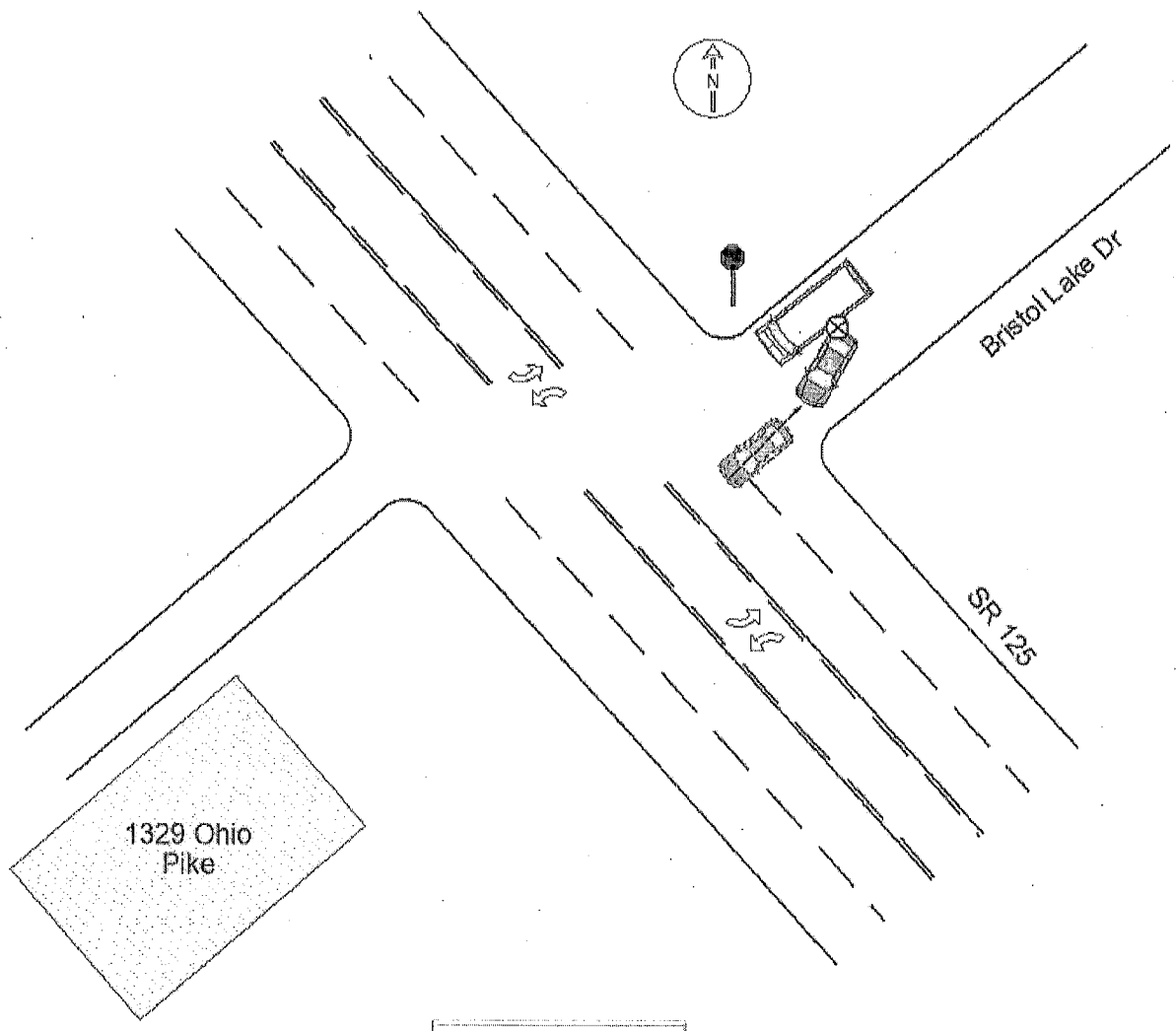
