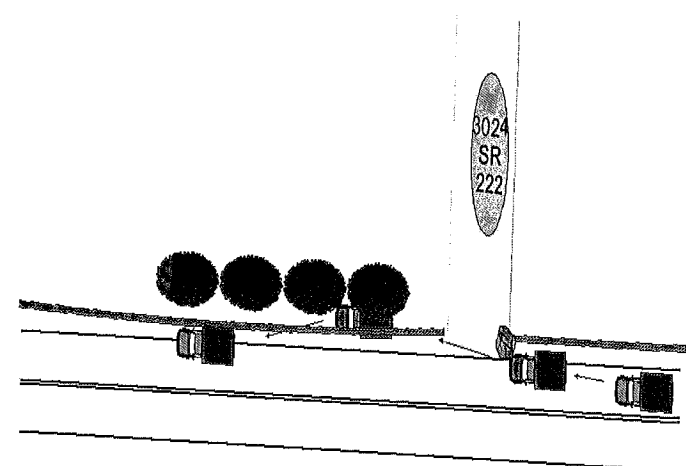

I responded to the area and located Unit #1 partially in the road way after it had struck the ditch at 3024 SR 222. The vehicle was traveling north bound on SR 222 when the driver fell asleep and went off the road to his right side. He struck the ditch, then a large boulder and mailbox at 3024 SR 222. He then glanced off of a tree and came to rest in the ditch line just north of 3024 SR 222. I made contact with the property owner Jane W Decantur. She stated that the driver had made arrangements to come back and fix the mailbox and driveway damage. The vehicle was disabled and Nicholasville Towing responded to remove the vehicle per the owners request.

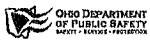
