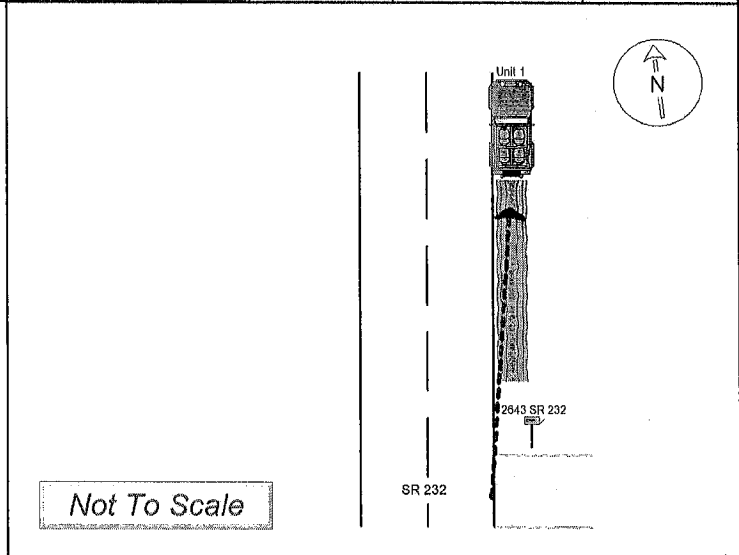

NARRATIVE  
On 01/18/22 at 2239 hours, I was dispatched to 2643 SR 232 for an MVA with possible injuries. I arrived and observed a green Jeep (Unit 1) stuck in the ditch. I made contact with the driver who advised he swerved to miss a deer and drove off the side of the road. Unit 1 was heading north on SR 232 when Unit 1 left the right side of roadway striking a mailbox at 2643 SR 232 and continued in the ditch for approximately 140 feet.

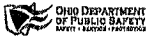

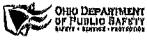

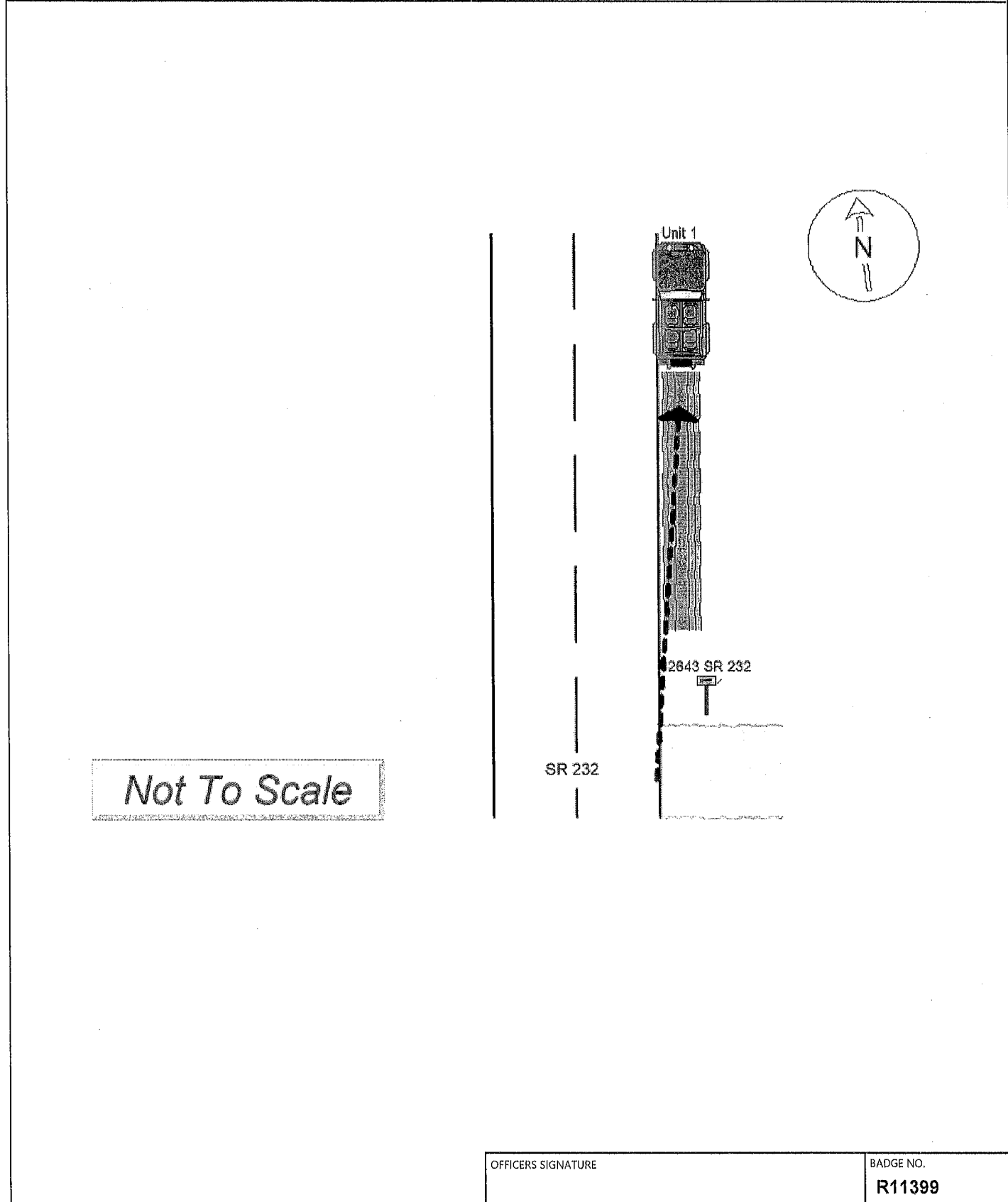
