NARRATIVE On January 25th, 2022, at 1630 hours I was dispatched to an injury crash on Old SR 32 near Zagar Rd. Dispatch advised that the caller stated that there was airbag deployment on Unit 1. When I arrived on scene, I made contact with the driver of Unit 2, Erick Martinez, who advised that he was preparing to turn onto Zagar when he was struck from behind by Unit 1. Both vehicles were towed from the scene by Tarvin Auto. I made contact with the driver of Unit 1, Paula Toole, at Clermont Mercy Hospital. She provided a statement advising that the vehicle in front of her stopped and she struck him. I issued Ms. Toole with a citation for ACDA.

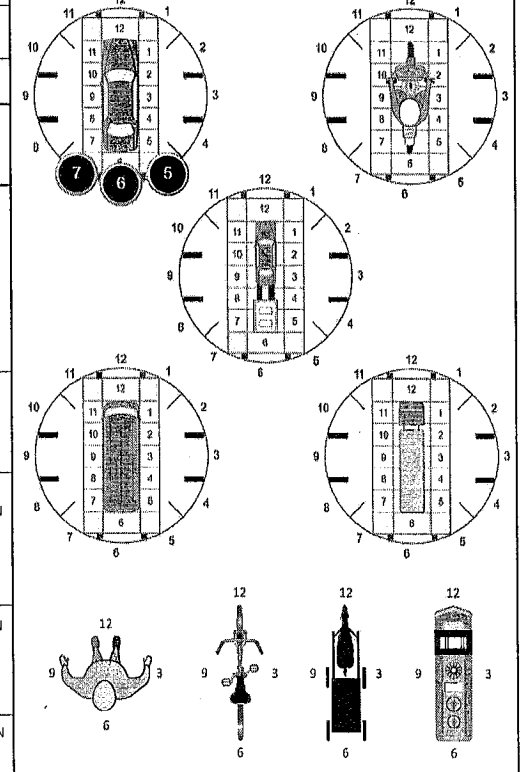

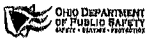

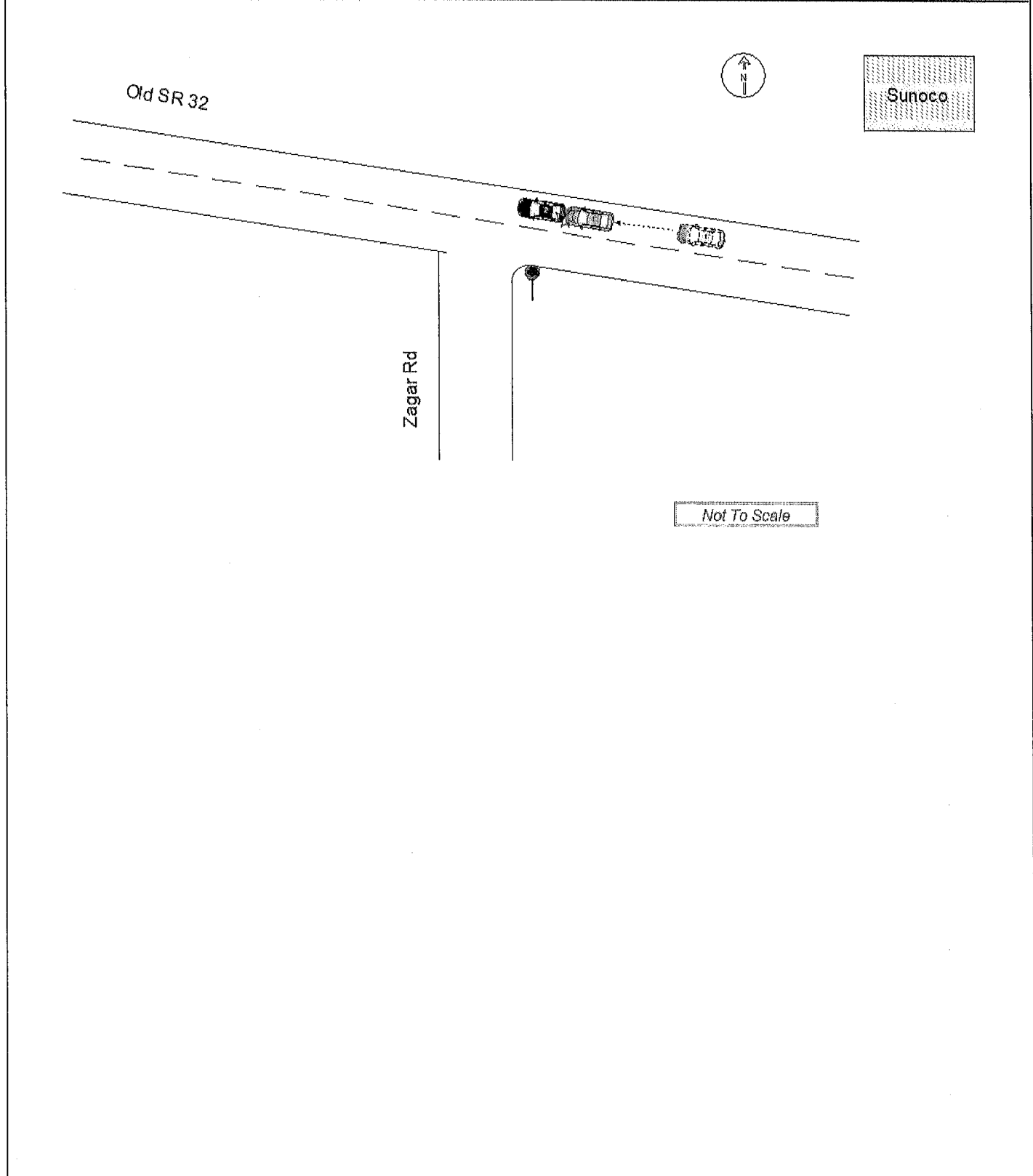
