Minor injuries were reported, Monroe Twp EMS checked the operator of Unit 1, who declined transport for higher level of care. Unit 1's vehicle was towed by Gray's towing at the owner's request. A citation was issued to the operator of Unit 1 for failure to control ORC 4511.202.

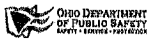

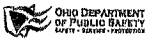
