NARRATIVE

On 3-30-2022 while working as duty officer a Kevin Griffin came into the Sheriff's office requesting a crash report for an accident that occurred at 0755 in front of 2355 Laurel Nicholasville Rd. Mr. Griffin stated that he was traveling north east on a narrow road when he passed a white mini van. While passing the mini van, both his vehicle and the mini van's mirrors struck causing minimal damage to his mirror. Mr. Griffin stated he then went up the road and turned around and responded back to a pull off to see if the van had pulled over. Mr. Griffin stated the van was not there. Photographs of Mr. Griffin's vehicle were taken at the Sheriff's office. Mr. Griffin stated he had no other information on the white van.

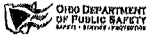
