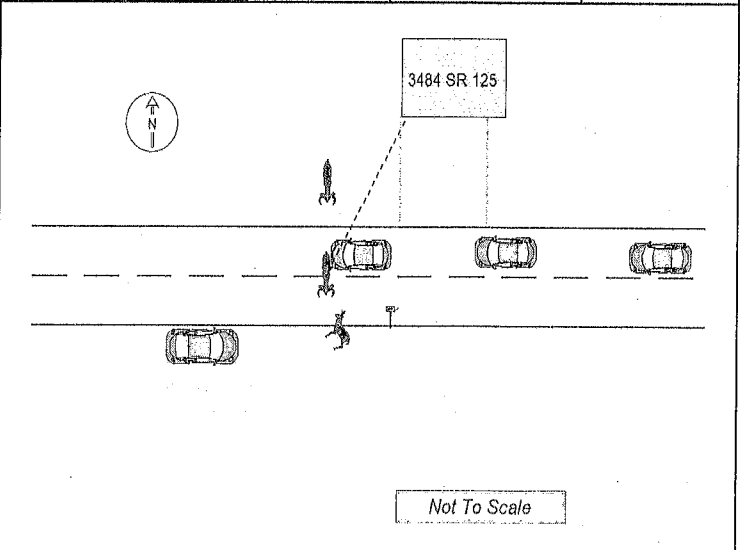

NARRATIVE

On April 7, 2022 at 0325 hours, I was dispatched to the area of 3484 State Route 125 in Tate Township for a single vehicle MVA (Vehicle vs Deer). Upon my arrival, I observed a silver Volkswagen Golf HB bearing OH- JCG2782 parked off the roadway with the hazard lights activated. The vehicle was facing EB with the deceased deer approximately 25 feet in front of the vehicle. The deer front portion of the deer was lying on the roadway and the back portion was lying in the grass. I made contact with the driver, Mr. Jack Brumley and the female passenger, Ms. Chloe Zahn. Jack explained to me that he was driving alone and was on the way to work when he struck the deer that jumped into the roadway. Jack advised that he was traveling WB and that the deer was traveling from the north to the south. Jack advised after the accident, he responded back to Chloe's residence (girlfriend) to pick her up and bring her back to the scene. Jack advised he did this because he has ever been in an accident before and that the vehicle belongs to Chloe. While speaking to Chloe she provided me with the proper documentations for the vehicle. It should be noted that Chloe resides within 2-3 minutes from the scene. The weather conditions are foggy, wet pavement, and dark.

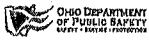
