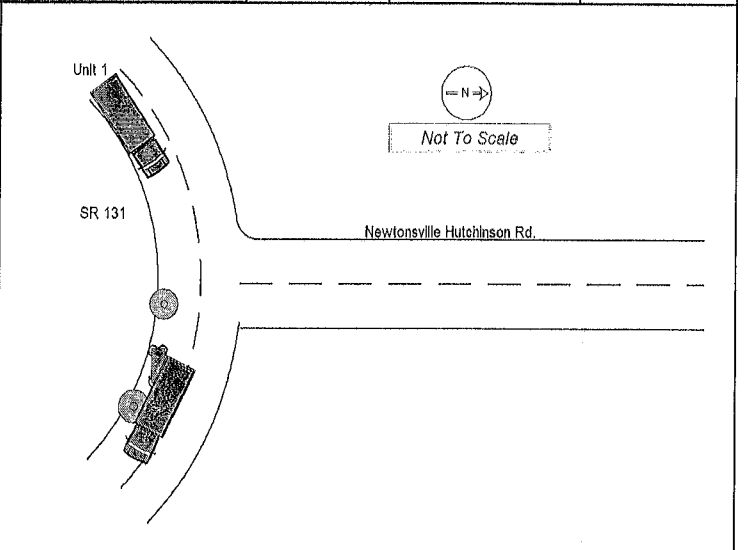

NARRATIVE

On 04/14/22 at approximately 10:18 hours I was dispatched to 1900 Sr 131 for a report of property damage. I met with a Wesley Fritts and his co worker Dave Dufresne. Both subjects work for Clermont County Water Resource's. Wesley Fritts advises they were working today at the intersection of Sr. 131 and Newtonsville Hutchinson Rd locating underground utility (water main) They had a locator base set over a water valve on Sr. 131 in the Westbound lane approximately 1' from the white line. They also had traffic cones set up to keep traffic from hitting their equipment. They then observed a large box truck traveling westbound on 131 with Smyth Automotive written on the side. As the truck approached the cones it started at go around the marked area but then another vehicle came around the bend heading Eastbound on Sr. 131. The large Box truck then tried to move over when it hit the locator equipment with its rear tire. The truck continued Eastbound while Wesley Fritz and Dave Dufresne yelled at the driver to stop. They then picked up their broken equipment and followed the truck to Smyth Automotive. I then contacted the driver of the box truck named Paul James. Mr. James advised he did just drive through this area but he didn't notice that he hit anything. Mr. James advised he had his radio on and didn't notice anything.

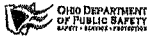

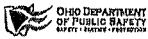

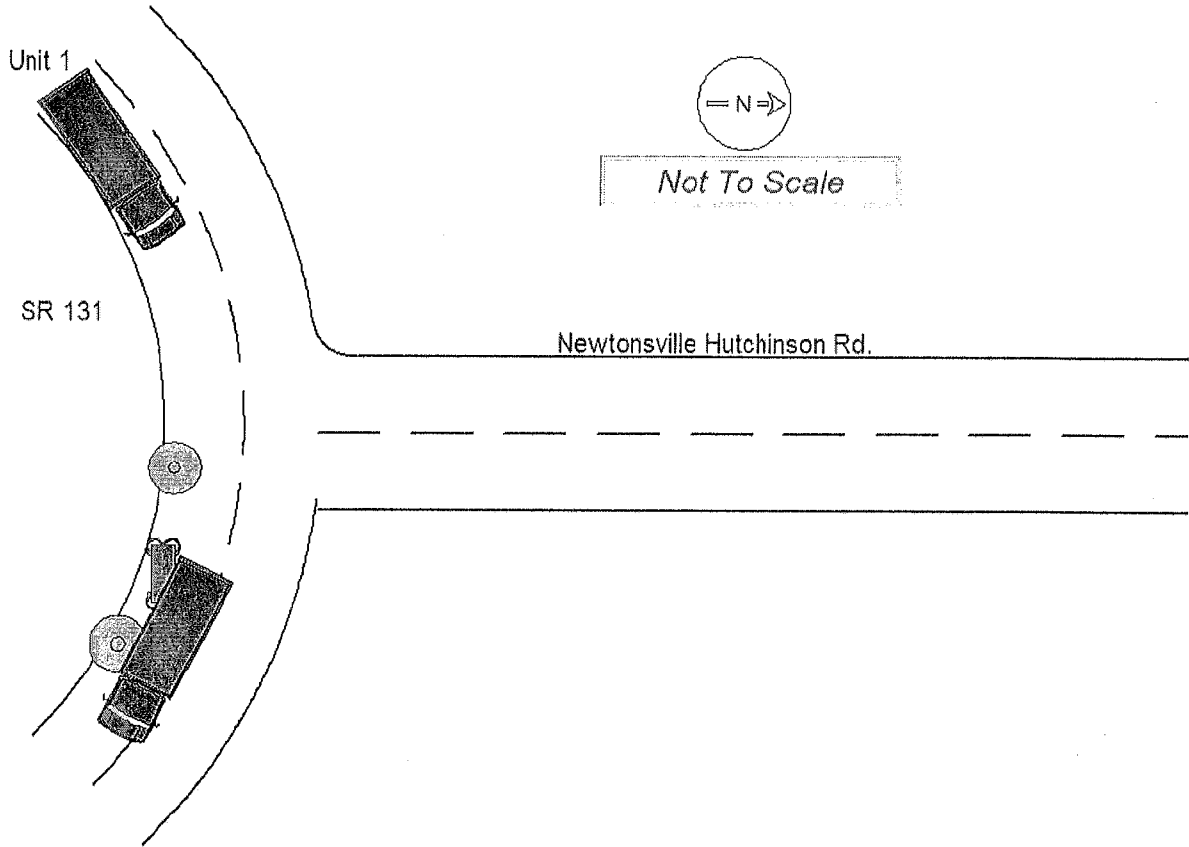
