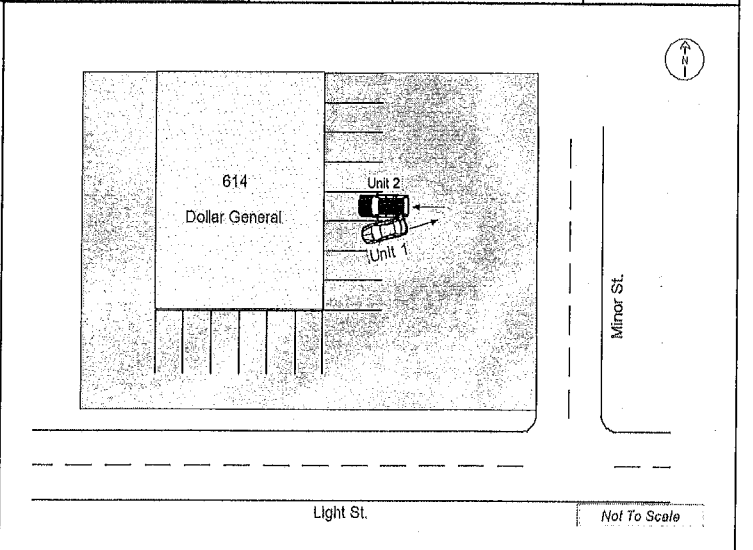

NARRATIVE
On 5-10-2022 at 1721 hours I responded to the Dollar General at 614 Light St in Felicity for a report of a 2 car MVA in the parking lot. Upon arrival, I made contact with Sandra Myers who was driving her 2022 Chevrolet Traverse. Ms. Myers stated she was attempting to pull into a parking spot when a vehicle backed out of another spot striking the rear driver side of her vehicle. I spoke with Brian Mahaffey who was driving his 2011 Chevrolet Malibu. Mr. Mahaffey stated he was backing out of his parking space and struck Ms. Myers with the rear passenger side of his vehicle. Mr. Mahaffey stated he did not see Ms. Myers pulling into the spot next to her. There was minor damage to both vehicles. Photographs were taken of the damage. Both Ms. Myers and Mr. Mahaffey stated they were not injured.

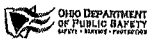
