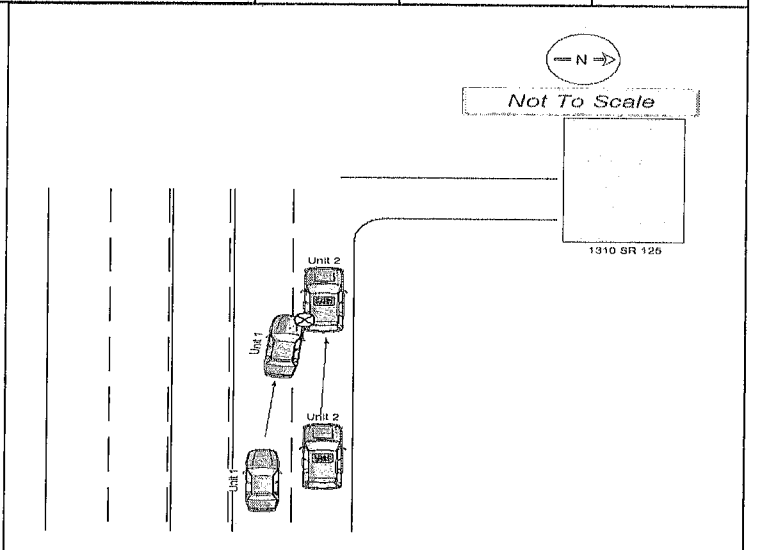

NARRATIVE

On 6/13/2022 I was dispatched to 1310 SR 125 in Batavia Twp for an accident without injuries. Upon arrival, I spoke with Mary McCarthy who advised she was driving a white Chevrolet sedan (OH/GQC5596 - Unit 1) westbound on SR 125. She stated she was in the left lane with her right turn signal on. Ms. McCarthy then stated she was going to the McDonald's which is on the south side of SR 125. Ms. McCarthy advised the other vehicle, a gold Chevrolet Equinox (OH/JSE7374 - Unit 2) came into her lane of travel and struck her vehicle which caused her to "spin" around in the roadway. Unit 2 advised they witnessed Ms. McCarthy enter the right lane of travel and they tried to avoid the collision by driving onto the right shoulder but their vehicle was still struck. The damage present was consistent to Unit 2's statement. Ms. McCarthy refused to provide a written statement on scene.

OHIO TRAFFIC ACCIDENT - OH2 DIAGRAM

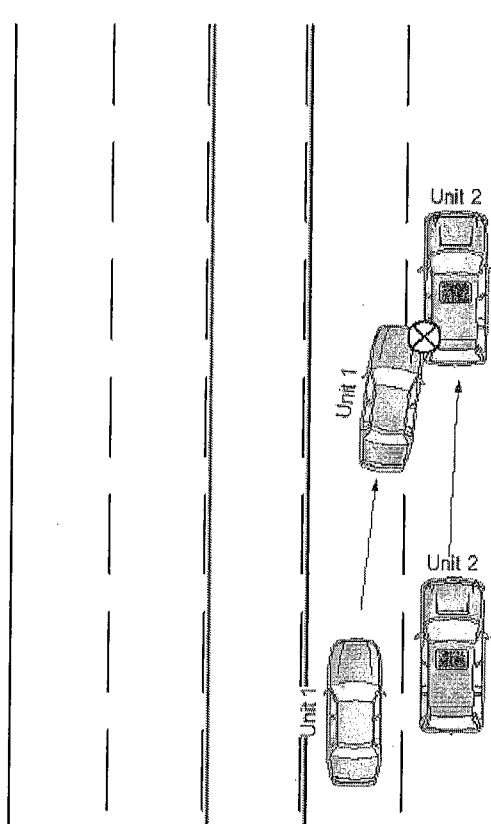
