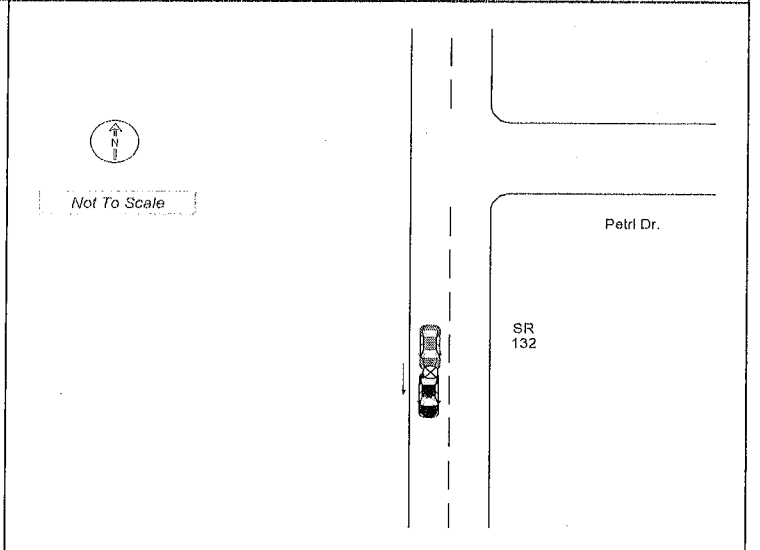

NARRATIVE

On July 11th, 2022, I was dispatched to a crash at SR 132 near E Concord Rd., Ohio Township. When I arrived on scene, EMS units advised the driver and passengers of Unit 1 were being transported to the hospital. I made contact with the driver of Unit 2, CG, and his father, David Gooch. They advised they were traveling southbound when they were struck from behind by Unit 1 after braking due to a vehicle from the northbound lane crossing the center line. Unit 2 was not towed and was able to be driven away from the scene. A witness, , advised that the driver of Unit 2 was braking to avoid striking a pick-up truck that went left of center. He stated Unit 2 began braking and Unit 1 struck Unit 2. On July 12th, 2022, I made contact with the occupants of Unit 1, CD, CD, and Devon Penny. All subjects advised the same as Mr. Brandstetter. Driver, CD, was cited for ACDA.

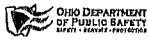

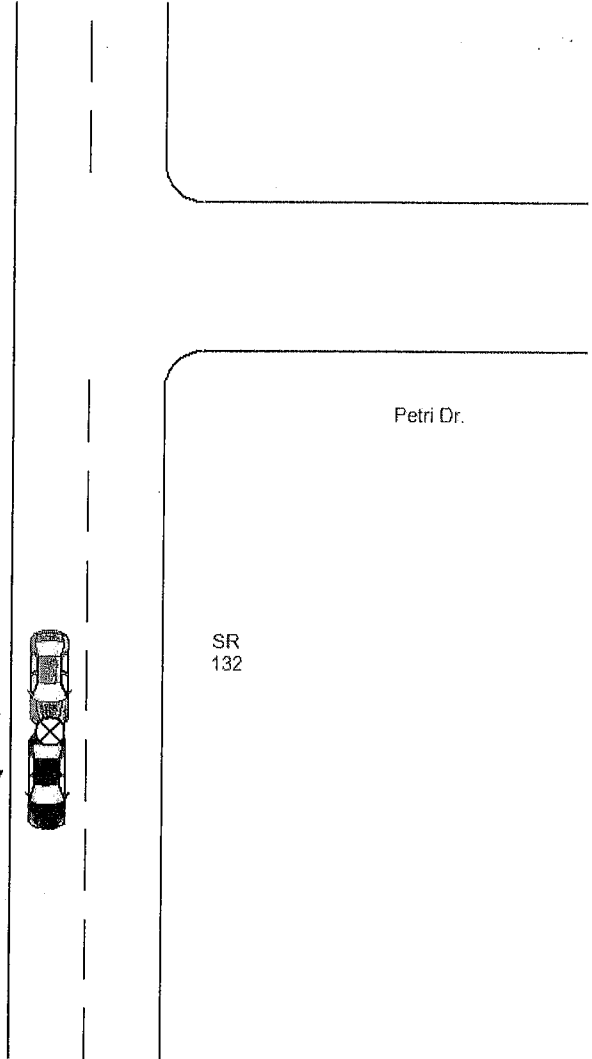
