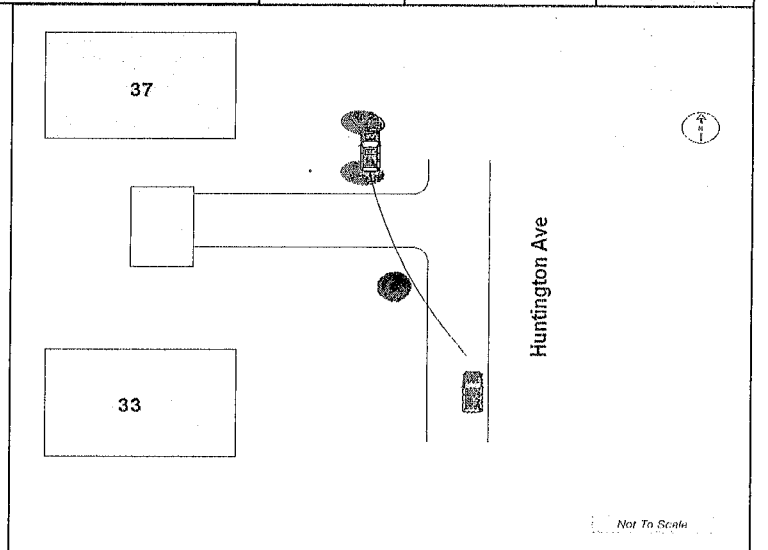

NARRATIVE
On July 12th, 2022, at 1926 hours I was dispatched to 37 Huntington Ave, Batavia Township for a hit/skip. When I arrived on scene, the homeowner, Paul Dunn, advised he was sitting outside when he heard a crash in front of his rental property. Mr. Dunn advised he observed a dark green Saturn van (JSD8237) stuck in the yard of his residence. He stated a male wearing a grey shirt and jeans got out of the vehicle picked up some of the parts of his vehicle and drove away. Mr. Dunn advised the vehicle had struck a small stump in his yard and then struck a large boulder. I observed wood chips from the stump and the boulder had been pushed approximately 10 feet. Vehicle parts were still lying near the boulder. The registered owner, Stephen Hunt, showed an address in Holly Towne MHP in RMS. I responded to this residence and the homeowner advised Mr. Hunt was now staying at a residence on Charmalee Dr. I responded to 56 Charmalee Dr. and made contact with David Bain. Mr. Bain advised Mr. Hunt stopped by for a short moment and left immediately. Mr. Bain advised Mr. Hunt was alone and normally drives the Saturn. Mr. Bain also advised Mr. Hunt was wearing a grey shirt and jeans. Based on this information I issued an open warrant to Mr. Hunt for DUS & Hit/Skip.
