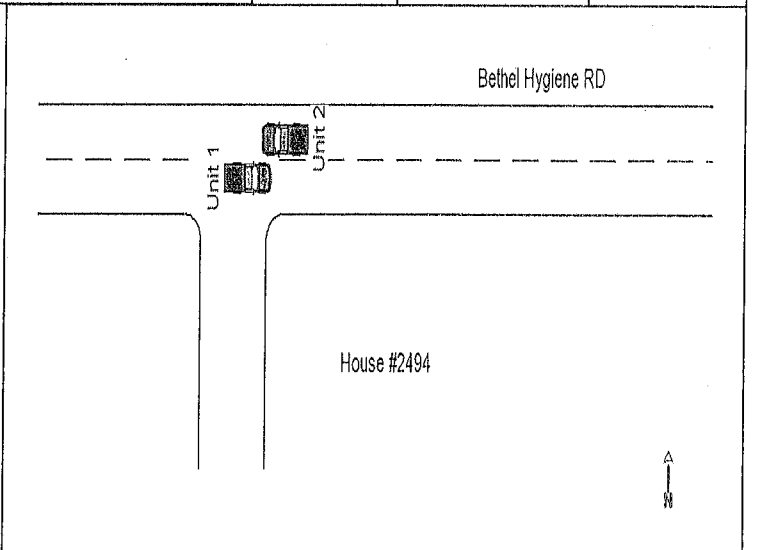

NARRATIVE
Unit #2 advised he was traveling west bound on Bethel Hygiene RD near house number 2494 when a red truck coming the opposite direction started to cross left of center causin their mirrors to hit. Unit #2 advised the red truck kept going an did not stop to wait for police. While I was still on scene, dispatched advised me that a Mr. Bobbie Neu was requesting that I call him advising he was the driver of the red truck involved in the accident. I contacted Mr. Neu over the phone who was already back at his residence in Mt Orab. He advised that he did not cross left of center. He advised that him and the pther vehicle were both close to the yellow line and just happened to hit mirrors. He advised he did not stay at teh scene because he thought the other vehicle was leaving and he wanted to get his passenger medical attention. I asked Mr. Neu where his passenger got medical attention at and he advised he did not get any because he ended up not bein injured. He advised his passenger inly had a small cut under his ear. Mt Orab PD responded to Unit #2 residence and obtained photos and statements from Mr. Neu and his passenger Danny Dickson.

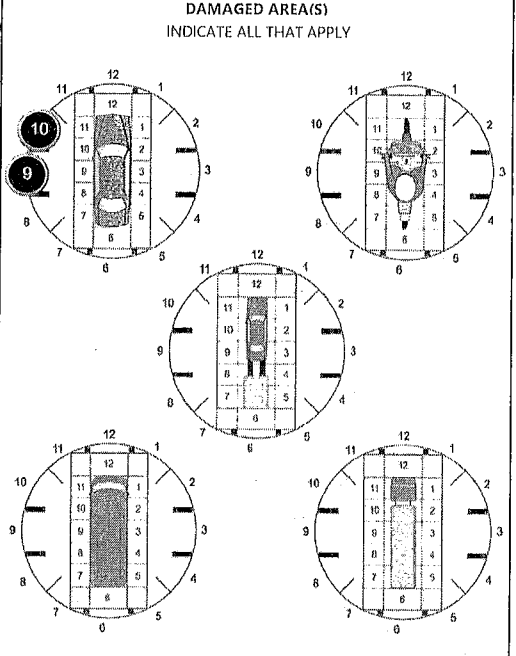

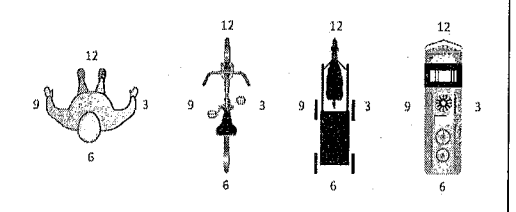
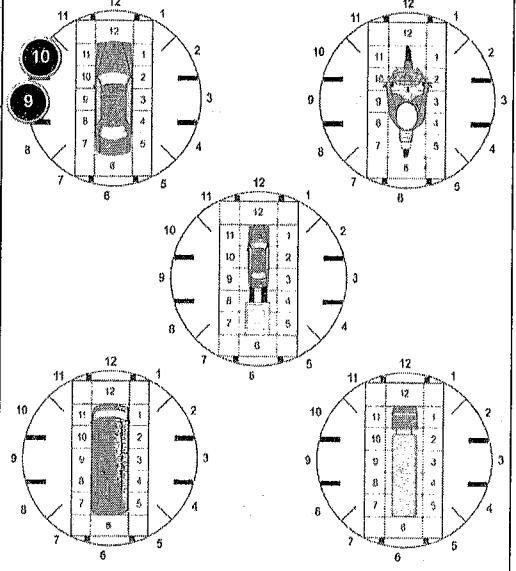
